This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i), namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended, of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. The North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 21<sup>st</sup> August 2000.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Public Footpath No. 46, Barrow upon Humber, Modification Order 2000".

SCHEDULE

PART 1

Modification of Definitive Map

Description of path or way to be deleted

The path heads north for 110 metres from Point A to Point B, then heads north west for 70 metres to Point C.

Description of path or way to be added

A footpath with a minimum width of 1.25 metres throughout running in a north-westerly direction from Point A for 28 metres to Point D, then in a north-north-

westerly direction for 25 metres to Point E, then in a north-easterly direction for 28 metres to Point F, then in a northerly direction for 10 metres to Point G, then in a north-easterly direction for 8 metres to Point H, then in a north-westerly direction for 76 metres to Point I, then in a north-easterly direction for 27 metres to Point J, then in a west-north-westerly direction for 18 metres to Point C.

## PART 2

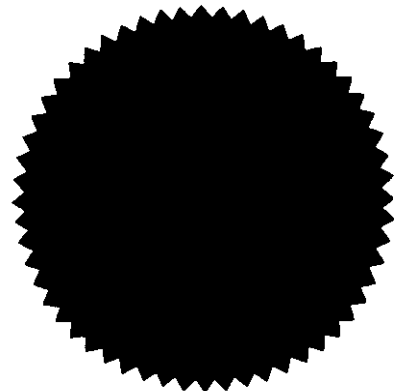
### Modification of Definitive Statement

#### Variation of particulars of path or way

From a point along the western side of Palmer Lane, 30 metres north of the southernmost end of Public Footpath 46, the footpath of a minimum width of 1.25 metres throughout proceeds generally north west for 30 metres, then crosses an access road off Palmer Lane, continuing in a north-north-westerly direction for 25 metres, then turns north east for a further 46 metres, arriving at a point across another access road off Palmer Lane, before heading in a north-westerly direction for 76 metres, then in a north-easterly direction for 27 metres, then in a west-north-westerly direction for 16 metres to a point west of the area of land known as Midby Park and 72 metres from the northernmost end of Public Footpath 46 on High Street.
