BYELAWS FOR GOOD RULE AND GOVERNMENT

Byelaws made under section 235 of the Local Government Act 1972 by the Council of North Lincolnshire for the good rule and government of the District of North Lincolnshire and for the prevention and suppression of nuisances.

Interpretation

1. In these byelaws:

"the Council" means the Council of North Lincolnshire.

Extent

2. These byelaws apply throughout the District of North Lincolnshire unless otherwise indicated.

USE OF MOTORCYCLES AND OTHER VEHICLES

Interpretation

3. In this byelaw:

"public pleasure ground" includes any pleasure ground or open space to which the Council's pleasure ground byelaws may apply, as indicated in the schedule to such byelaws;

"open land" means any land, whether enclosed or not, which is used as an amenity or for purposes of recreation or lies waste or unoccupied.

Use of Motorcycles etc

4. No person shall ride, drive or operate any motor bicycle or any other mechanically propelled vehicle not intended or adapted for use on roads other than a vehicle constructed or adapted for the conveyance of an invalid on any open land within the District from which the public is not excluded, including footpaths and bridleways, not being land forming part of a road or public pleasure ground or housing amenity green.

Provided that this byelaw shall not apply to any person taking part in a rally, trial, race or any other event held on any open land in pursuance of an agreement with the council or landowner.

PRESERVATION OF ROAD MARGINS/VERGES

Interpretation

5. In these byelaws:

"carriageway", "highway" and "trunk road" have the same meaning as in the Highways Act 1980.

Extent

- 6. These byelaws apply to any road margin or verge which is:
 - adjacent to the carriageway of a highway, other than to the carriageway of a trunk road vested in the Secretary of State; and
 - ii. laid or sown with grass and/or wild flowers or planted with trees, shrubs or plants, and mown or otherwise maintained in an ornamental condition by the Council, and
 - iii. indicated to be a margin or verge to which these byelaws apply by means of a notice conspicuously displayed on or near the said margin or verge by the Council.

Riding on Road Margins

7. No person shall without lawful authority ride or lead any horse, or cause any horse to be ridden or led upon any road margin or verge to which this byelaw applies.

Vehicles

- 8. No person shall, without lawful authority, drive, park or leave a vehicle (other than a heavy commercial vehicle as defined by section 20 of the Road Traffic Act 1988) or cause such a vehicle to be driven or placed upon any road margin or verge to which this byelaw applies.
- No person shall, without lawful authority, place materials or use any plant or heavy machinery upon any road margin or verge to which this byelaw applies.

SKATEBOARDING

Interpretation

10. In these byelaws:

"highway" means the whole or a part of a highway other than a ferry or waterway.

"carriageway" means a way constituting or comprised in a highway, being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

"footway" means a way comprised in a highway which also comprises a carriageway, being a way over which the public have a right of way on foot only;

Extent

- 11.(1) Byelaw number 12(1) applies throughout the District of North Lincolnshire but not to any designated area.
- 11.(2) Byelaw number 12(2) applies to all designated areas.
- 12.(1) No person shall on any footway or carriageway skate, slide or ride on rollers, skateboards, wheels or other mechanical contrivances or other equipment in such a manner as to cause danger or nuisance or give reasonable grounds for annoyance to other persons lawfully using the footway or carriageway.
- 12.(2) No person shall skate, slide or ride on rollers, skateboards, wheels or other mechanical contrivances or other equipment in a designated area. The designated areas are shown in the Schedule to these byelaws.

NOISE IN STREETS AND OTHER PUBLIC PLACES

- 13. No person in a street or other public place shall, after being requested to desist by a constable, or by any person annoyed or disturbed, or by any person acting on his behalf:
 - (a) by shouting or singing;
 - (b) by playing on a musical instrument; or
 - (c) by operating or permitting to be operated any radio, gramophone, amplifier, tape recorder or similar instrument

cause or permit to be made any noise which is so loud or so continuous or repeated as to give reasonable cause for annoyance to other persons in the neighbourhood.

14. This byelaw shall not apply to properly conducted religious services or to any person holding or taking part in any entertainment held with the consent of the Council.

SHOOTING GALLERIES ETC

No person shall in any street or public place, or on any land adjoining or near to any street or public place, keep or manage or cause to be kept or managed, a shooting gallery, swing-board, roundabout, or any other construction of a like character, so as to cause obstruction or danger to the traffic in such street or public place.

DANGEROUS GAMES NEAR STREETS

16. No person shall on any land adjoining a street play any game in a manner likely to cause obstruction to any traffic or to cause danger to any person in such a street.

TOUTING

17. No person shall in any street or public place for the purpose of selling or advertising any article or obtaining custom tout or importune to the annoyance or obstruction of passengers.

FIREWORKS ETC IN PLACES OF ENTERTAINMENT

18. No person shall, with intent to cause annoyance or inconvenience to any person in any place of entertainment to which the public are admitted with or without the payment of money, while the public are on the premises, throw or set off any firework, stink-bomb or similar article, or squirt, spray or otherwise throw or scatter any offensive liquid, powder or substance in any such place as aforesaid.

INTERFERENCE WITH ROAD WARNING LAMPS

19. No person shall in any street, to the obstruction, annoyance or danger of the residents or passengers, without lawful authority move or tamper with any lamp, reflector or other apparatus used for giving warning of, or lighting, any obstruction, excavation or other danger.

INTERFERENCE WITH LIFE SAVING APPLIANCES

20. Except in case of emergency no person shall remove, displace or otherwise interfere with any life saving appliances placed by the Council or other competent authority in any street or public place.

TOBOGGANING

21. No person shall in any street or public place coast downhill upon any toboggan or sledge or upon any wheeled trolley or similar vehicle, to the danger of any other person in such street or public place.

URINATING ETC

22. No person shall urinate or defecate in any public place.

PENALTY

23. Any person offending against any of these byelaws shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale.

REVOCATION

- 24. The byelaws for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as they relate to the area of North Lincolnshire, which were made by the Council of the County on the ninth day of February 1927, sent to His Majesty's Principal Secretary of State for the Home Department on the ninth day of February 1927 and which came into operation on the eleventh day of April 1927 are hereby revoked.
- 25. The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the third day of May 1929 and sent to His Majesty's Principal Secretary of State for the Home Department on the twenty seventh day of May 1929 and which came into force after forty days from that date is hereby revoked.
- The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the thirty first day of January 1930 and sent to His Majesty's Principal Secretary of State for the Home Department on the twenty eighth day of February 1930 and which came into force after forty days from that date is hereby revoked.
- 27. The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the twenty fifth day of October 1935 and confirmed by John Simon, one of His Majesty's Principal Secretaries of State, on the twenty third day of January 1936 is hereby revoked.
- 28. The byelaws for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as they relate to the area of North Lincolnshire, which were made by the Council of the County on the twenty seventh day of January 1939 and confirmed by Samuel Hoare, one of His Majesty's Principal Secretaries of State, on the twenty second day of March 1939 are hereby revoked.
- 29. The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the ninth day of December 1949 and confirmed by the Secretary of State on the twenty fifth day of January 1950 is hereby revoked.
- The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the twenty eight day of July 1950 and confirmed by the Secretary of State on the seventh day of December 1950 is hereby revoked.

- 31. The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the twenty ninth day of May 1953 and confirmed by the Secretary of State on the seventeenth day of August 1953 is hereby revoked.
- The byelaw for the good rule and government of the County of Lincoln, Parts of Lindsey and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the twenty seventh day of July 1959 and confirmed by the Secretary of State for the Home Department on the twenty seventh day of October 1959 is hereby revoked.
- 33. The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the nineteenth day of November 1965 and confirmed by the Secretary of State for the Home Department on the second day of March 1966 is hereby revoked.
- The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the twenty second day of July 1966 and confirmed by the Secretary of State for the Home Department on the twenty seventh day of December 1966 is hereby revoked.
- The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the sixteenth day of May 1969 and confirmed by the Secretary of State for the Home Department on the twenty fifth day of July 1972 is hereby revoked.
- The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire, which was made by the Council of the County on the seventeenth day of May 1968 and confirmed by the Secretary of State for the Home Department on the twenty seventh day of September 1968 is hereby revoked.
- 37. The byelaw for the good rule and government of the County of the Parts of Lindsey, Lincolnshire and for the prevention of nuisances, so far as it relates to the area of North Lincolnshire which was made by the Council of the County of the fourteenth day of December 1973 and confirmed by the Secretary of State for the Home Department on the twenty seventh day of March 1974 is hereby revoked.
- 38. The byelaws for the good rule and government of the Borough of Scunthorpe and for the prevention of nuisances made by the Council of the Borough on the eleventh day of February 1947 and confirmed by J Chuter Ede, one of His Majesty's Principal Secretaries of State, on the thirty-first day of March 1947 are hereby revoked.

- The byelaw for the good rule and government of the Borough of Scunthorpe made by the Scunthorpe Borough Council on the twenty-eighth day of March 1962 and confirmed by the Secretary of State for the Home Department on the eighteenth day of June 1962 is hereby revoked.
- 40. The byelaw for the good rule and government of the Borough of Scunthorpe made by the Council of the Borough on the thirtieth day of June 1966 and confirmed by the Secretary of State on the sixth day of September 1966 is hereby revoked.
- 41. The byelaws for the good rule and government of the Borough of Boothferry and for the prevention of nuisances, so far as they relate to the area of North Lincolnshire, which were made by the Boothferry Borough Council on the twenty-third day of November 1983 and confirmed by the Secretary of State for the Home Department on the seventeenth day of April 1984 are hereby revoked.
