PUBLIC PATH EXTINGUISHMENT ORDER

HIGHWAYS ACT 1980 AND WILDLIFE AND COUNTRYSIDE ACT 1981

PUBLIC PATH (PUBLIC FOOTPATH 191, BOTTESFORD) ORDER 2009(1)

This order is made by North Lincolnshire Council ("the authority") under section 118 of the Highways Act 1980 because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this order) of a highway hitherto shown or required to be shown in the map and statement.

BY THIS ORDER:

The public right of way over the land situate at Bottesford and shown by a continuous bold line on the map attached to this order and described in the Schedule to this order shall be extinguished after 42 days from the date of confirmation of this order and thereupon the "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive map and statement shall be modified accordingly.

SCHEDULE

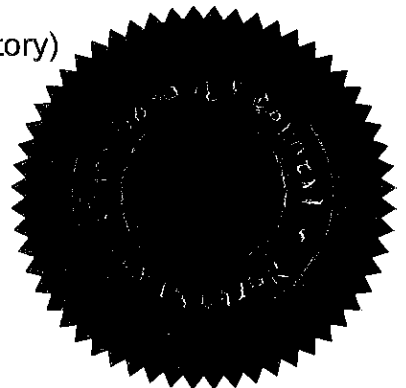
A – B, as indicated on map: a footpath of an approximate total length of 724 metres leading first northwards for about 154 metres from a point on Moorwell Road opposite its junction with High Street at grid reference SE88640702 to a point adjacent to the southwest corner of the property at 71 High Leys Road at grid reference SE88620717; continuing in a north-easterly direction for about 312 metres to a point within the curtilage of the property at 4 Sandringham Crescent at grid reference SE88770744; and finally in an east-north-easterly direction for about 258 metres to a point on Messingham Road just south of its junction with Keddington Road at grid reference SE89010751.
