**Definitive Map Modification (Public Footpath 3, Alkborough) Order 2005(1)**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3<sup>rd</sup> May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 3, Alkborough) Order 2005(1).

**Description of path to be deleted**

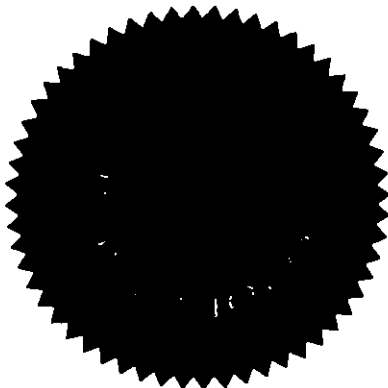
*A – B as indicated on the map:* A 460-metre-long footpath commencing on the existing footpath at grid reference SE8795021482, proceeding across enclosures 185 and 192 in a southerly direction passing at its southern end through the grounds of Walcot Hall and to the east and south east of the said Hall to its junction with Burton Stather Road approximately 300 feet south east of the said Hall at grid reference SE8784921022.

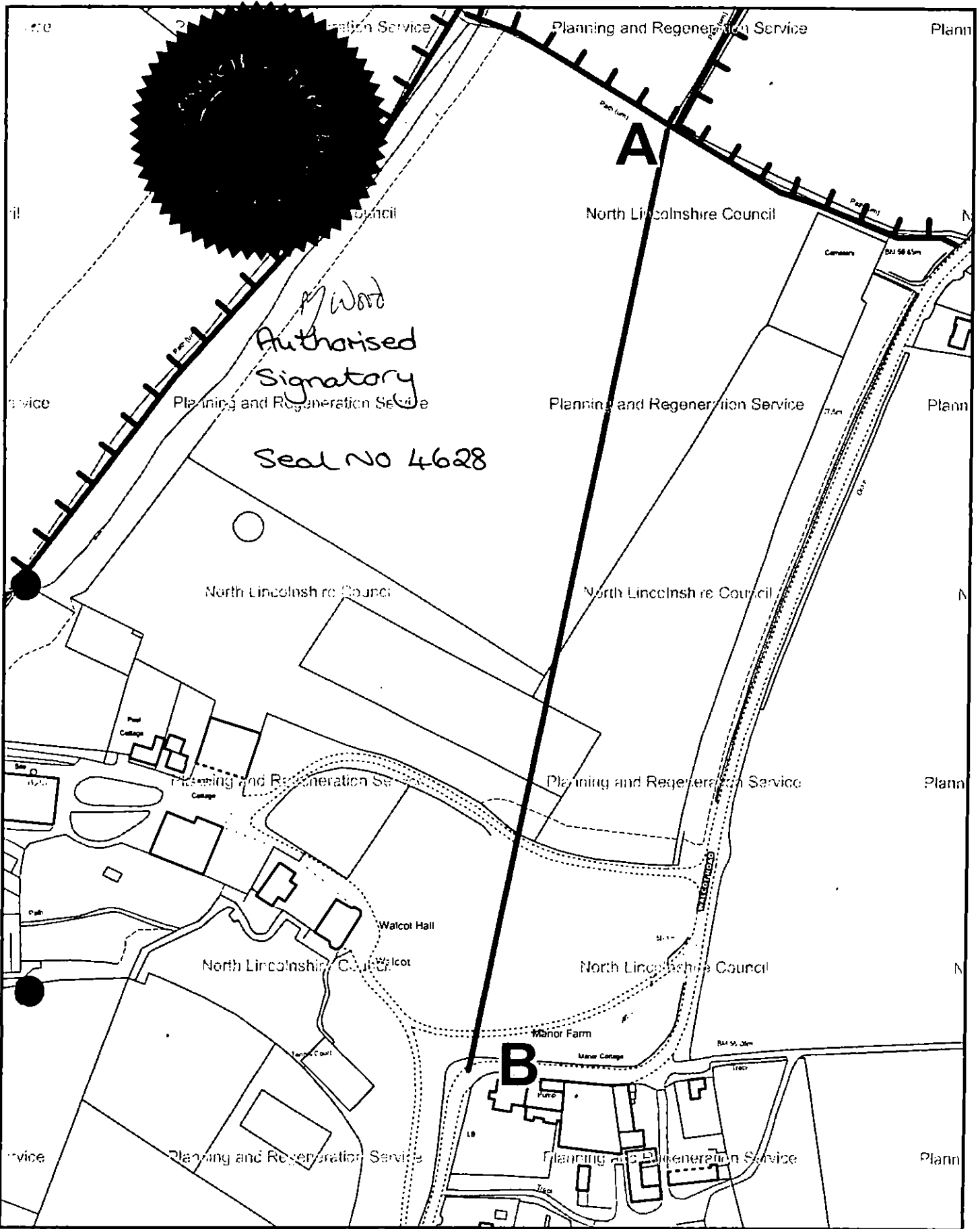
