**Definitive Map Modification (Barnetby FP 295) Order 2012**

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 6 February 2012.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the Definitive Map Modification (Barnetby FP295) Order 2012.

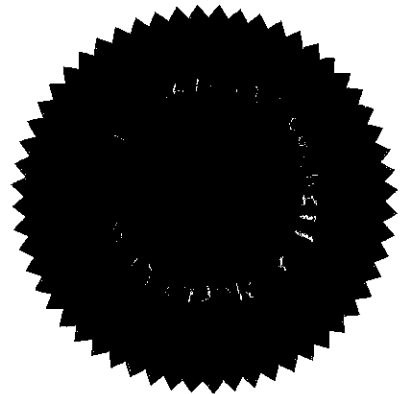

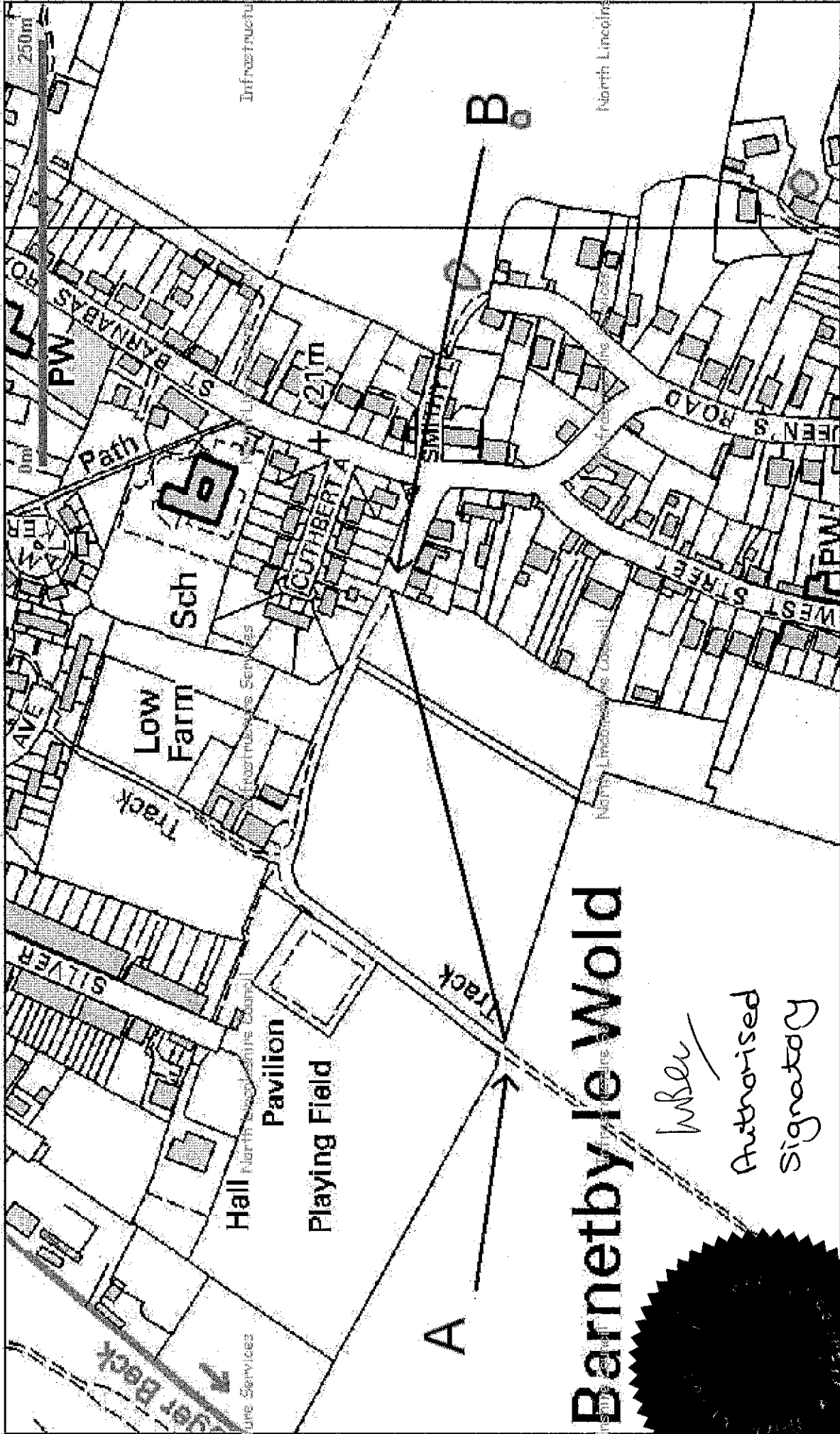
### PART 1

*A – B as indicated on the map:* A 272-metre-long footpath commencing at the junction of the existing footpath No.295 and No.296 at the south western corner of a field at grid reference TA0551809478, proceeding diagonally across the same field in a north-easterly direction to a point on the existing footpath No.145 and the south side of a property known as No.17 Cuthbert Avenue at grid reference TA0577709550.
