Definitive Map Modification (Public Footpath 32, Barton) Order 2005(2)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3rd May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 32, Barton) Order 2005(2).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 405-metre-long footpath commencing on the existing footpath on the south bank of the River Humber at grid reference TA0184323380, proceeding along an access track between O.S. Field number 6300 and O.S. Field numbers 8800 and 9224 on the east in a southerly direction to its junction with the unclassified public highway known as Far Ings Lane at grid reference TA0183822978.



Description of path to be added

A – B as indicated on the map: a 195-metre-long footpath with a width of 1.80 metres commencing on the existing footpath some 210 metres west of the junction with Waterside Road at grid reference TA0259023411, proceeding beneath the Humber Bridge along the south bank of the River Humber in a westerly direction to a point on the existing footpath at grid reference TA0239023406.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 195-metre-long footpath with a width of 1.80 metres commencing on the existing footpath some 210 metres west of the junction with Waterside Road at grid reference TA0259023411, proceeding beneath the Humber Bridge along the south bank of the River Humber in a westerly direction to a point on the existing footpath at grid reference TA0239023406.

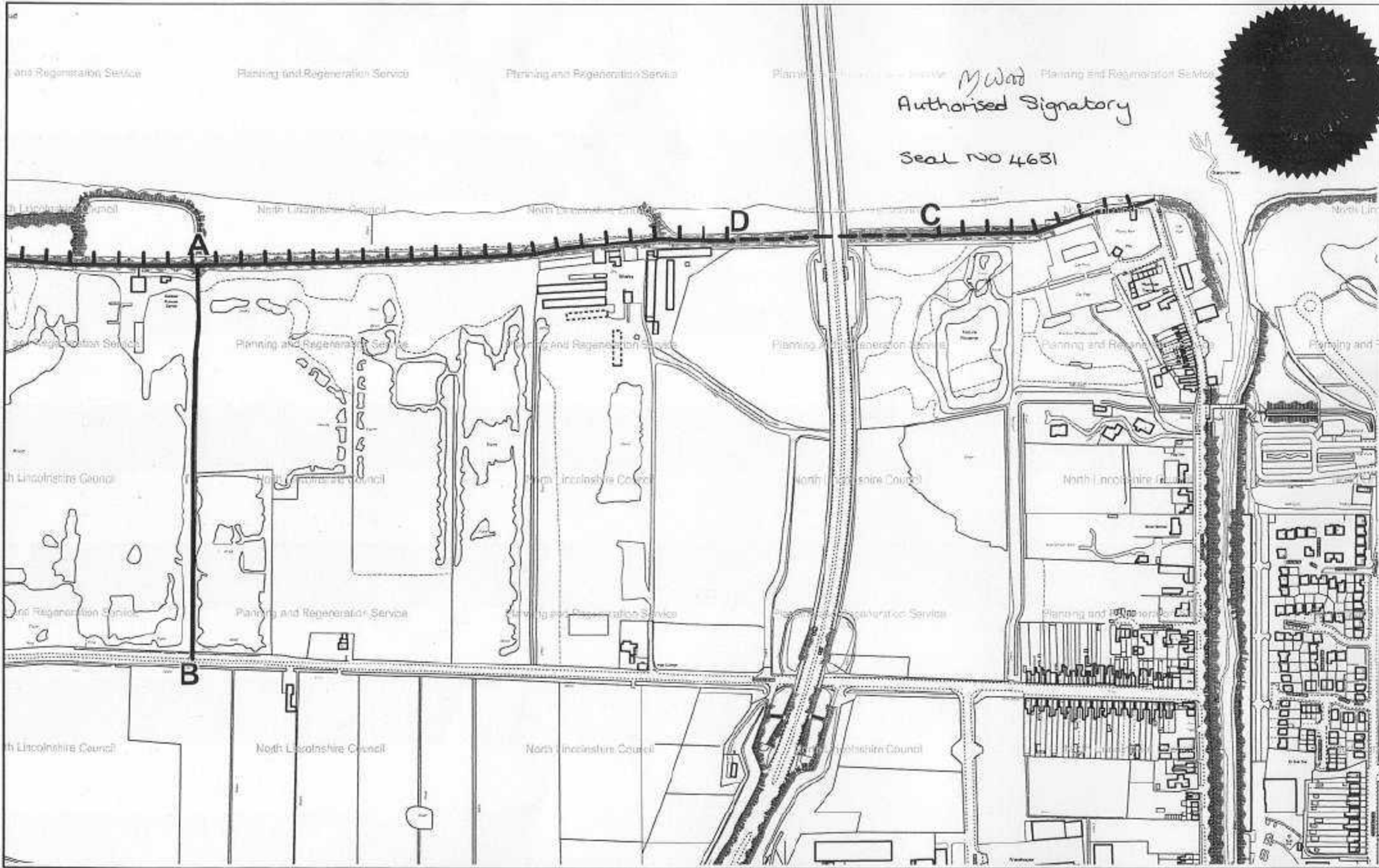

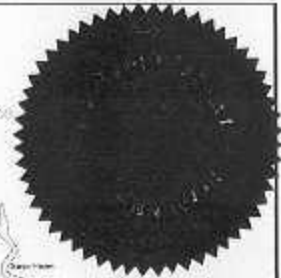
