Wildlife and Countryside Act 1981

County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

"Definitive Map Modification (Public Footpath, 39B, Barton Upon Humber) Order 2006 (1)"

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 18th August 2006.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath, 39B, Barton Upon Humber) Order 2006 (1)".

SCHEDULE

PART I

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be added

A – B, as indicated on the map: A 265-metre-long public footpath with a width of 5 metres running from grid reference TA0292422874 in a northerly direction to grid reference TA0292323138.

PART II

Modification of Definitive Statement

Variation of particulars of path

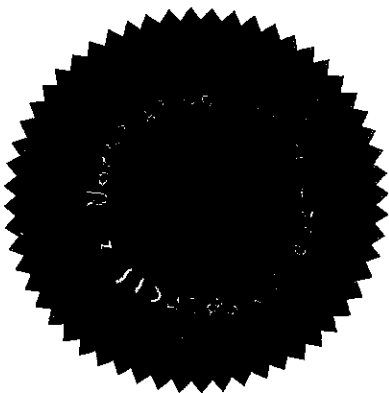
A 265-metre-long footpath five metres wide throughout commencing at a point along the northern perimeter of the car park serving Proudfoot's supermarket at grid reference TA0292322874 and proceeding in a northerly direction along a surfaced track that runs between on the one hand the long narrow building known as the Ropewalk close to its western flank and on the other properties belonging to Ropery Lane, Manilla Lane and Loyalty Lane close to its eastern flank to a point in the perimeter of the Waters' Edge Country Park at grid reference TA0292323126 thence continuing to its junction with footpath 39 at grid reference TA0292323138.

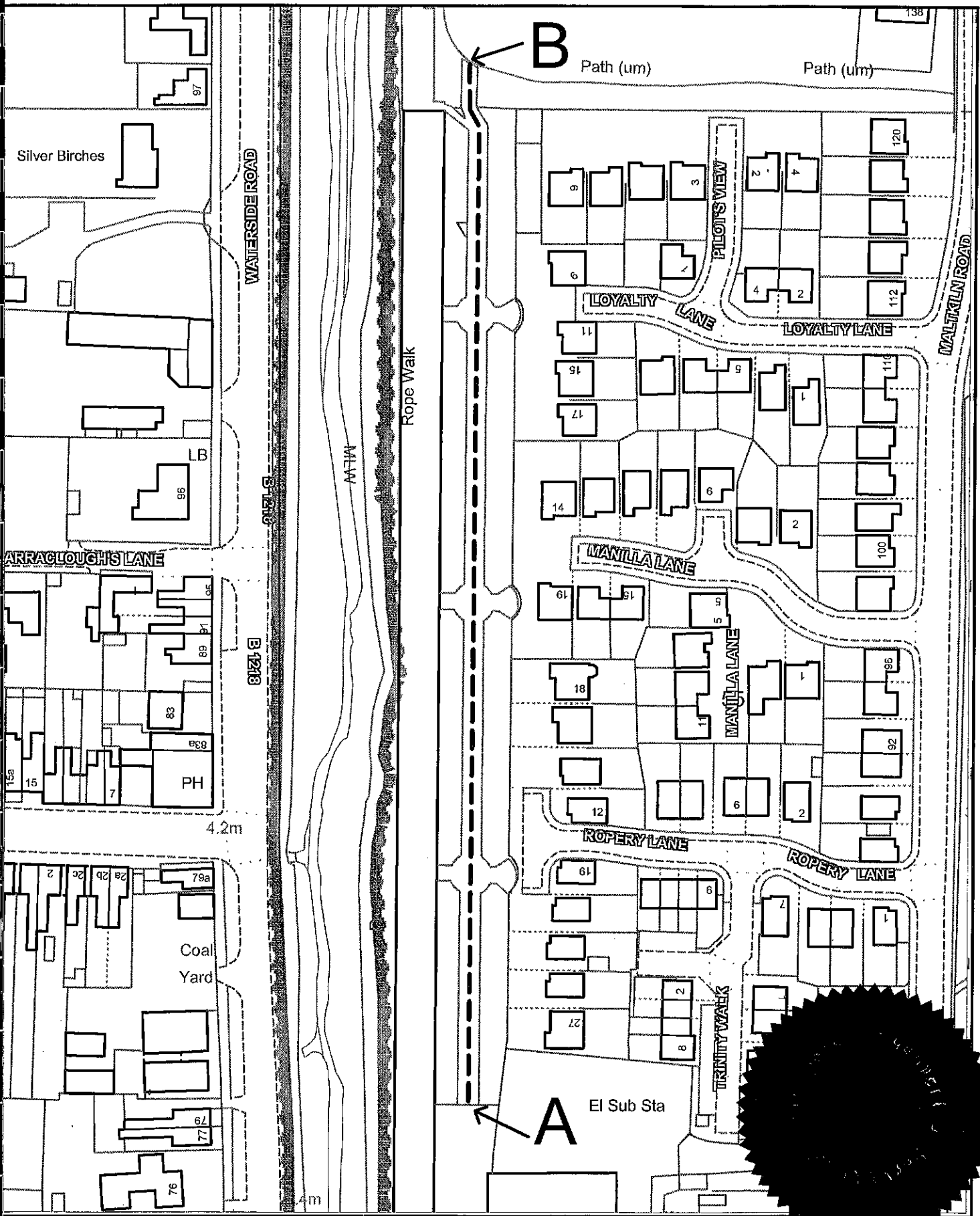
