PUBLIC FOOTPATH 42 BELTON 2009(1)

This order is made by North Lincolnshire Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the public it is expedient that the line of the path should be diverted.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 (the 1981 Act) because it appears to the authority that the "County of Lincoln, Parts of Lindsey (Isle of Axholme)" definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the Wildlife and Countryside Act 1981, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated at Stockholes Turbary in the Parish of Belton and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 42 days from the date of confirmation of this order and thereupon the "County of Lincoln, Parts of Lindsey (Isle of Axholme)" definitive map and statement shall be modified accordingly.
2. There shall at the end of 42 days from the date of confirmation of this order be a public footpath over the land situate at Belton described in Part 2 of the Schedule and shown by a bold black broken line on the map attached to this order and thereupon the "County of Lincoln, Parts of Lindsey (Isle of Axholme)" definitive map and statement shall be modified accordingly.

SCHEDULE

PART 1

Description of site of existing path

Point A—H as indicated on the map: a 484 -metre-long footpath commencing at grid reference SE76620721 and leading southwesterly to grid reference SE76190699.

PART 2

Description of site of new path

Point A—B as indicated on the map: a 97-metre-long footpath with a width of three metres commencing at grid reference SE76620721 and leading northwesterly along an established stone track to grid reference SE76550727.

Point B—C as indicated on the map: a 221-metre-long footpath with a width of three metres commencing at grid reference SE76550727 and leading southwesterly along an established track to the north-western corner of a property known as Brigadoon at grid reference SE76360716.

Point C—D as indicated on the map: a 145-metre-long footpath with a width of 2.5 metres commencing at grid reference SE76360716 and leading southwesterly along an established grass track to the entrance of a property known as Corner Acre at grid reference SE76230708.

Point D—E as indicated on the map: a 4-metre-long footpath with a width of 2.5 metres commencing at grid reference SE76230708 and leading north westerly along an established grass track to the north east corner of a property known as Corner Acre at grid reference SE76230708.

Point E—F as indicated on the map: a 73-metre-long footpath with a width of two metres commencing at grid reference SE76230708 and leading southwesterly along the southern boundary of a small field to grid reference SE76160705.

Point F—G as indicated on the map: a 65-metre-long footpath with a width of two metres commencing at grid reference SE76160705 and leading south between South Engine Drain and the western boundary of the property known as Corner Acre to grid reference SE76170699.

Point G—H as indicated on the map: a 13-metre-long footpath with a width of two metres commencing at grid reference SE76170699 and leading east along the parish boundary of Belton and Epworth to rejoin the part of Public Footpath 42 at a point adjacent to Folly Drain at grid reference SE76190699.

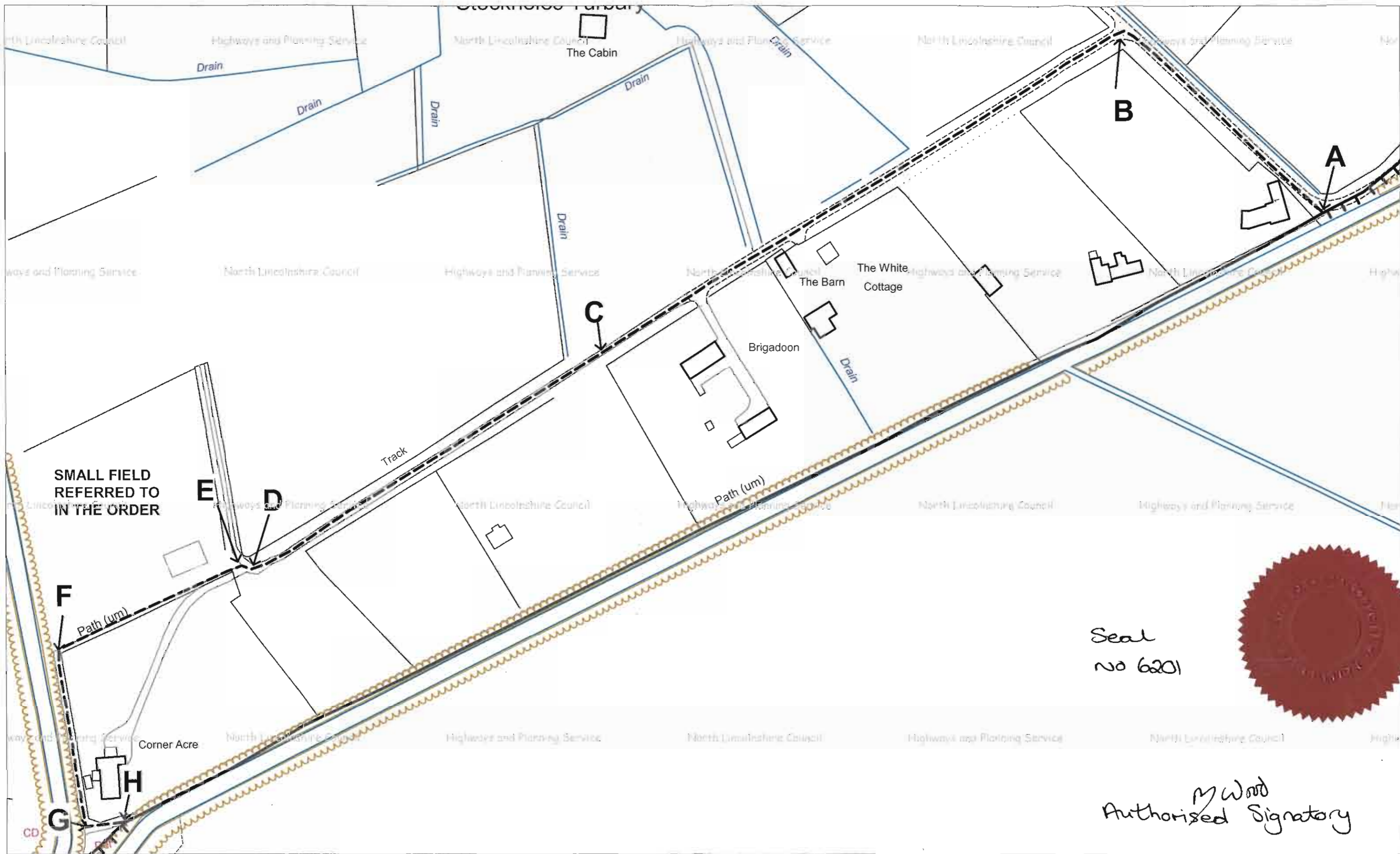
