**Definitive Map Modification (Public Footpath 198 Bottesford)  
Order 2007(3)**

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) - namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 29<sup>th</sup> June 2007.
2. The County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.

This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 198 Bottesford) Order 2007(3).

## SCHEDULE

### PART 1

#### Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

##### Description of path to be deleted

*A – B as indicated on the map:* A 42-metre-long footpath commencing on the junction of Cherry Mount and Timberlands adjacent to a property known as No.25 Timberlands at grid reference SE9006407535 and proceeding in a northerly direction to its junction with the remaining footpath at the north-eastern corner of a property known as No.4 Cherry Mount at grid reference SE9007007576.

##### Description of path to be added

*C – D as indicated on the map:* A 32-metre-long footpath with a width of 1.8 metres commencing on a highway known as Timberlands at a point adjacent to the northern boundary of a property known as No.32 Timberlands adjacent to the north-west corner at grid reference SE9006207519, proceeding over the footway along the south side of Timberlands in an easterly direction to a point on the same highway adjacent to the north-west corner of a property known as No.36 Timberlands at grid reference SE9009207529.

*E – B as indicated on the map:* A 40-metre-long footpath with a width of 1.9 metres commencing on the north side of a highway known as Timberlands at a point adjacent to the south-east corner of a property known as No.25 Timberlands at grid reference SE9008907541 and proceeding along a line adjacent to the eastern side of properties known as No.25 Timberlands, No.2 Cherry Mount and No.4 Cherry Mount in a north-westerly direction to its junction with the existing footpath at a point adjacent to the north-eastern corner of a property known as No.4 Cherry Mount at grid reference SE9007007576.

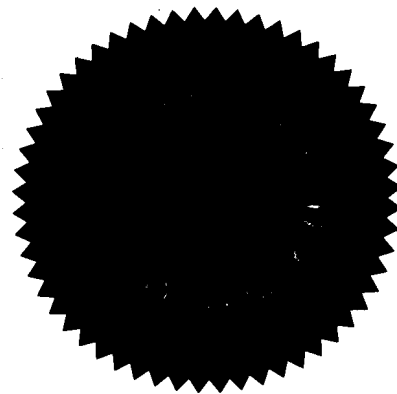
Variation of particulars of path

A 72-metre-long footpath with a width of 1.8 and 1.9 metres commencing on a highway known as Timberlands at a point adjacent to the northern boundary of a property known as No.32 Timberlands at grid reference SE9006207519 and proceeding over the footway along the south side of Timberlands in an easterly direction to a point on the same highway adjacent to the north-west corner of a property known as No.36 Timberlands at grid reference SE9009207529 and then northwards along a line adjacent to the eastern side of properties known as No.25 Timberlands, No.2 Cherry Mount and No.4 Cherry Mount to its junction with the existing footpath at a point adjacent to the north-eastern corner of a property known as No.4 Cherry Mount at grid reference SE9007007576.

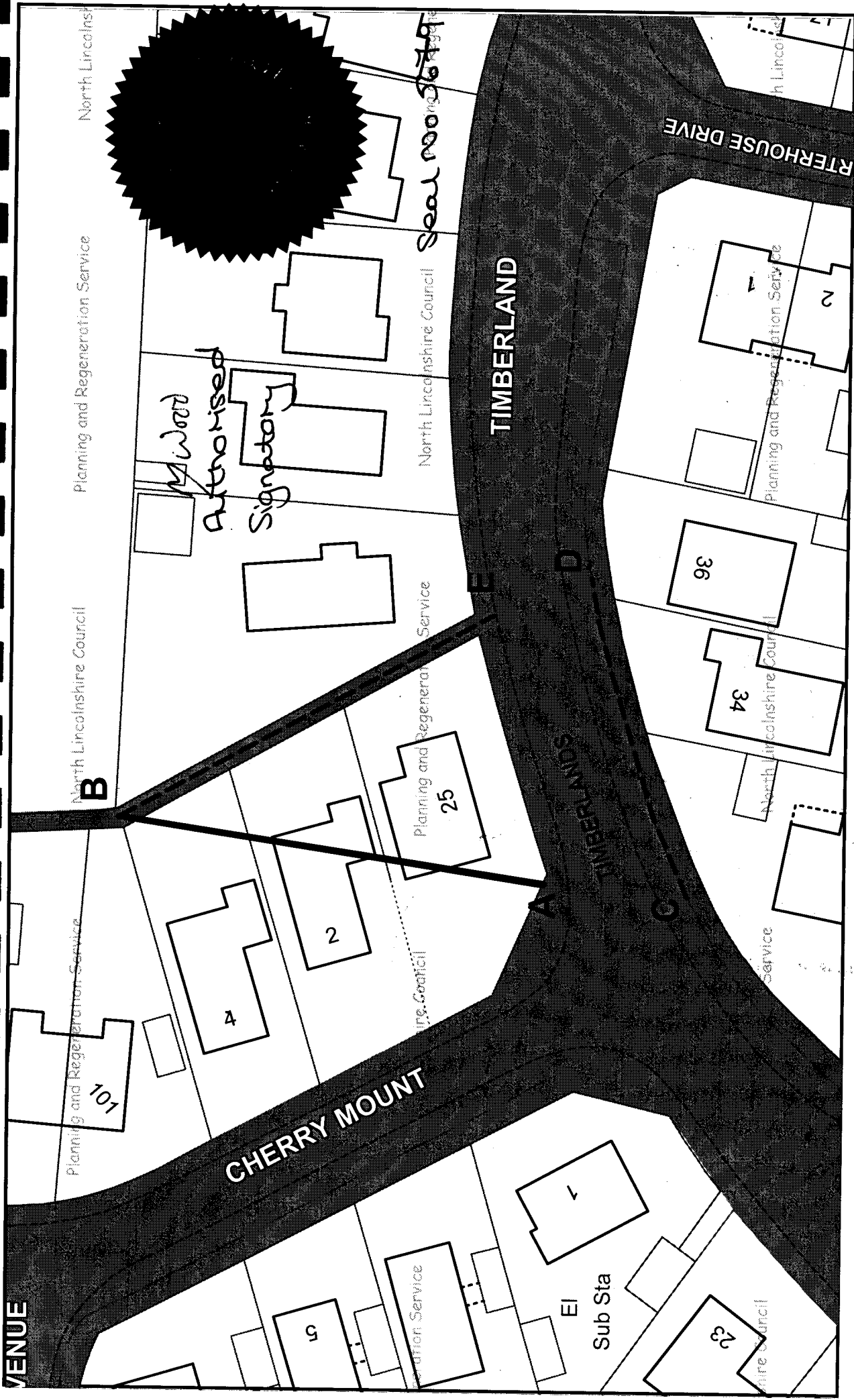
