**County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement**

**"Definitive Map Modification (Public Footpath 57, Brigg) Order 2006(2)"**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming in to operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and the statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 30<sup>th</sup> August 2006.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath 57, Brigg) Order 2006 (2)".

**SCHEDULE**

**PART I**

**Modification of Parts of Lindsey (Glanford Brigg) Definitive Map**

**Description of path to be added**

*A – B, as indicated on the map: An 87-metre-long footpath with a width of 5.5 metres running from a point on Bigby High Road at grid reference TA0166306988 in a south-south-westerly direction along a track following the eastern side of a hedge to grid reference TA01636806902.*

PART II

Modification of Definitive Statement

*Variations of Particulars of Path*

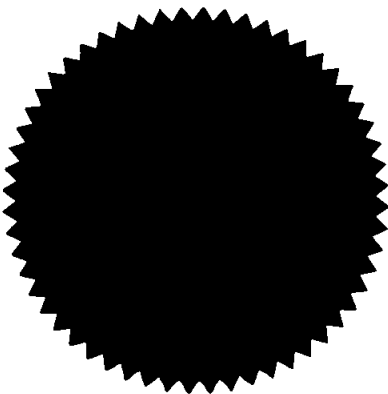
An 87-metre-long footpath commencing on Bigby High Road at grid reference TA0166306988 and proceeding along a stone and grass track in a south-south-westerly direction to Bigby Parish boundary to grid reference TA0163806902 at the edge of the boundary for North Lincolnshire. The footpath shall have a width of 5.5 metres comprising of a 3 metre stone track and adjacent 2.5 metres grass verge.

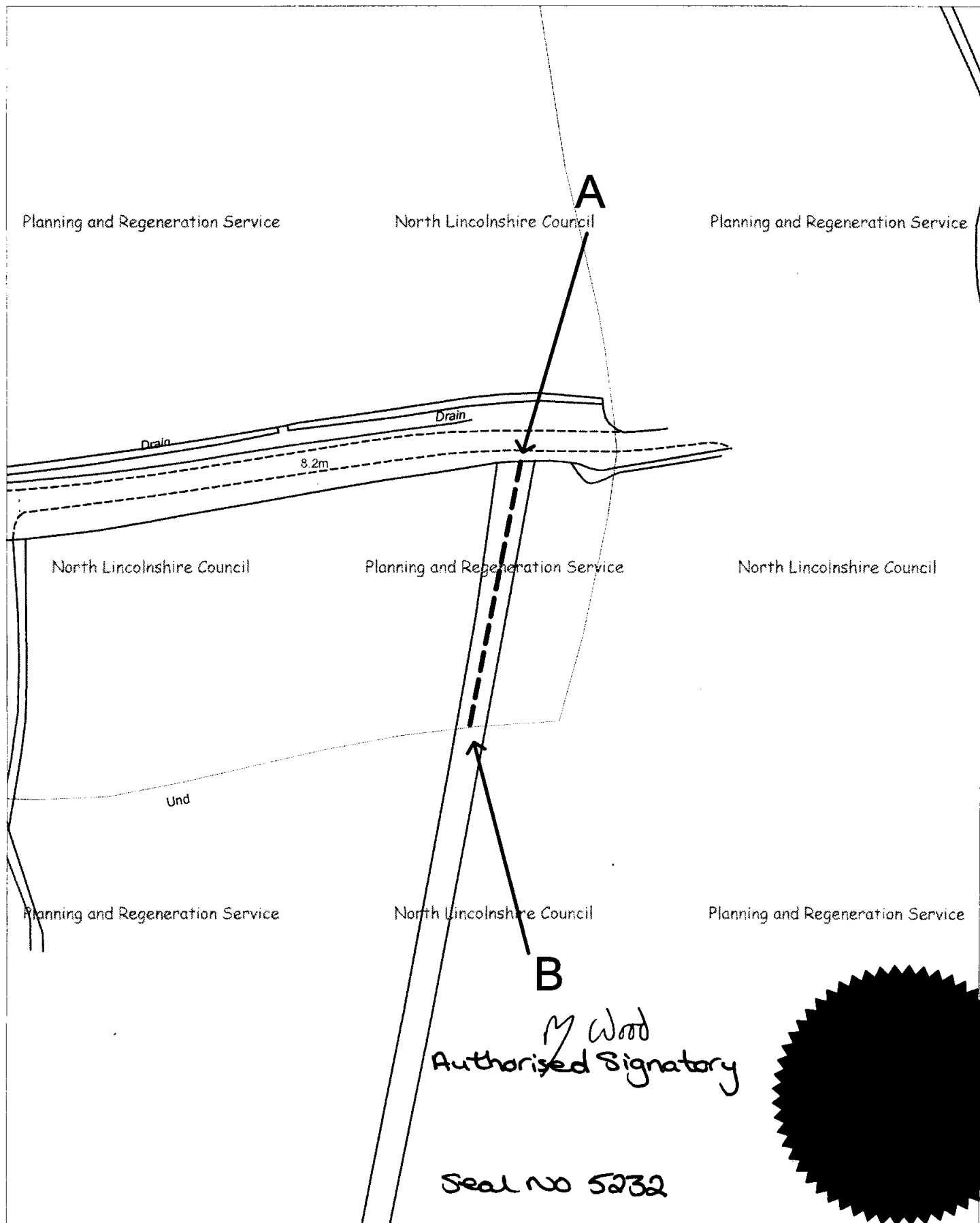
