It relates to the Definitive Map and Statement for the County of Lincoln – Parts of Lindsey (Glanford Brigg) and is made in pursuance of the provisions of the Wildlife and Countryside Act 1981.

WILDLIFE AND COUNTRYSIDE ACT 1981

DEFINITIVE MAP MODIFICATION (Public Footpath 214, Broughton) Order 2005(1)

1. For the purposes of this Order, the date is 10th April 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be amended in accordance with Part 1 and Part 2 of the Schedule and shall be deemed to have effect from the date of this Order.
3. This Order shall take effect on the day on which it is made and the Definitive Map Modification (Public Footpath 214, Broughton) Order 2005(1).

Definitive Map Modification (Public Footpath 214, Broughton) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 18th April 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 214, Broughton) Order 2004(2).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B, as indicated on the map: A 124-metre-long footpath commencing at grid reference SE9371310223 that leads in an east-south-easterly direction to grid reference SE9383110189.

Description of path to be added

A – C, as indicated on the map: A 141-metre-long footpath commencing at grid reference SE9371310223 heading in a north-easterly direction for 40 metres to grid reference SE9374410250.

C - B, as indicated on the map: The path changes at grid reference SE9374410250 to a generally south-easterly direction for 101 metres to grid reference SE9383110189 (Point B) as indicated on the map. The footpath has a minimum width of 0.91 metres throughout.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement *Variation of particulars of path*

A 141metre-long footpath commencing at FP 214 at the north-east corner of Little Crow Covert, grid reference SE9371310223 and leading in a north-easterly direction along a track for 40 metres to grid reference SE9374410250, then changing to a generally south-easterly direction for 101 metres across an arable field to a point south-west of Gokewell Priory at grid reference SE9383110189. The footpath has a minimum width of 0.91 metres throughout.

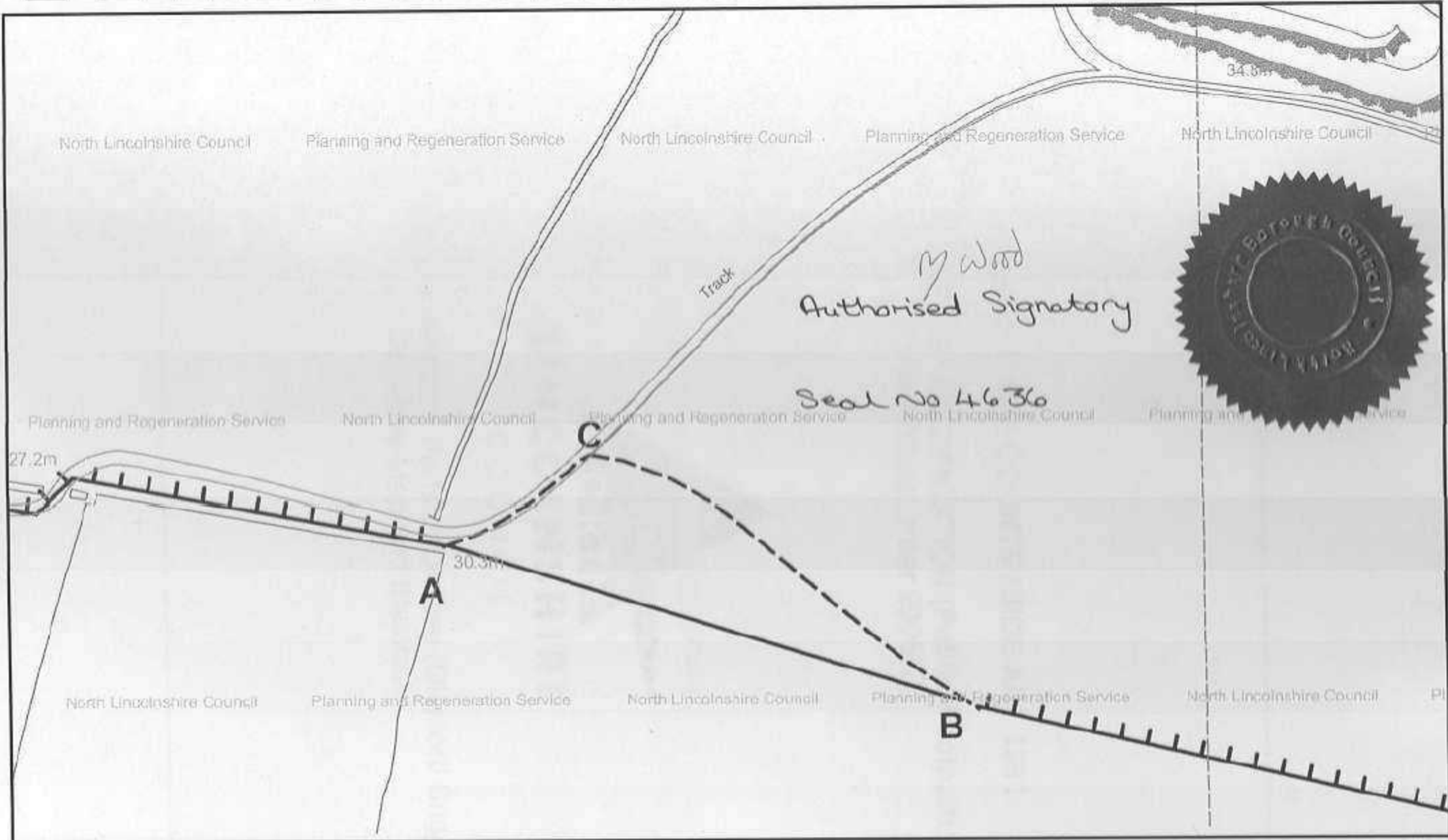
