Definitive Map Modification (Public Footpath 226, Broughton) Order 2004(1)

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 26th January 2004.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 226, Broughton) Order 2004(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B: A 337-metre-long footpath commencing at grid reference SE9677608659 that runs diagonally across a field in a south-easterly direction to grid reference SE9704408458, as indicated on the map.

Description of path to be added

C – B: A 222-metre-long footpath with a width of 1.37m commencing at grid reference SE9700608678 and following the eastern boundary of a field to grid reference SE9704408458, as indicated on the map.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

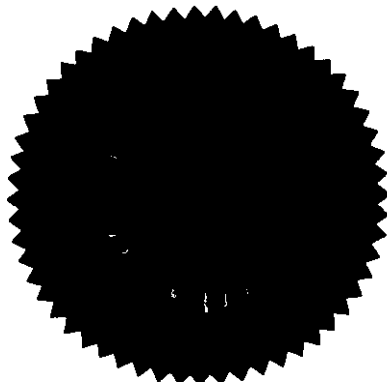
A 222-metre-long footpath with a width of 1.37m commencing at Brigg Road grid reference SE9700608679 and following the eastern boundary of a field in a southerly direction to join footpath 226 at grid reference SE9704408458.
