County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

Definitive Map Modification (Public Footpath 134, Elsham) Order 2008(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) - namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended - of the Act.

North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 4th January 2008.
2. The "County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement" shall be modified as described in Part 1 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 134, Elsham) Order 2008(1).

SCHEDULE

PART 1

Modification of "The County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map"

Description of path to be deleted

A – B as indicated on the map: a 34-metre-long footpath commencing on Front Street at the eastern end of the driveway of a property known as School House at grid reference TA03671265, and proceeding along the driveway leading to School House in a south-westerly direction to a point at the south-eastern corner of the driveway at grid reference TA03651263.

B – C as indicated on the map: a 40-metre-long footpath commencing at the south-eastern corner of the driveway belonging to a property known as School House at grid reference TA03651263, and proceeding across a lawned area

in a south-westerly direction to a point at the northern end of a wooded area at grid reference TA03631259.

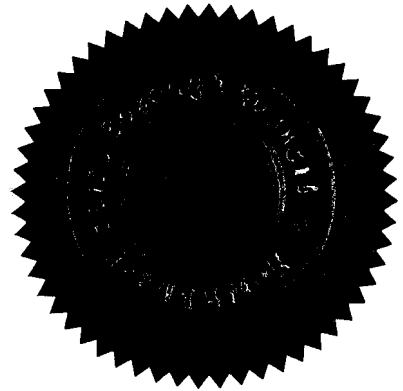

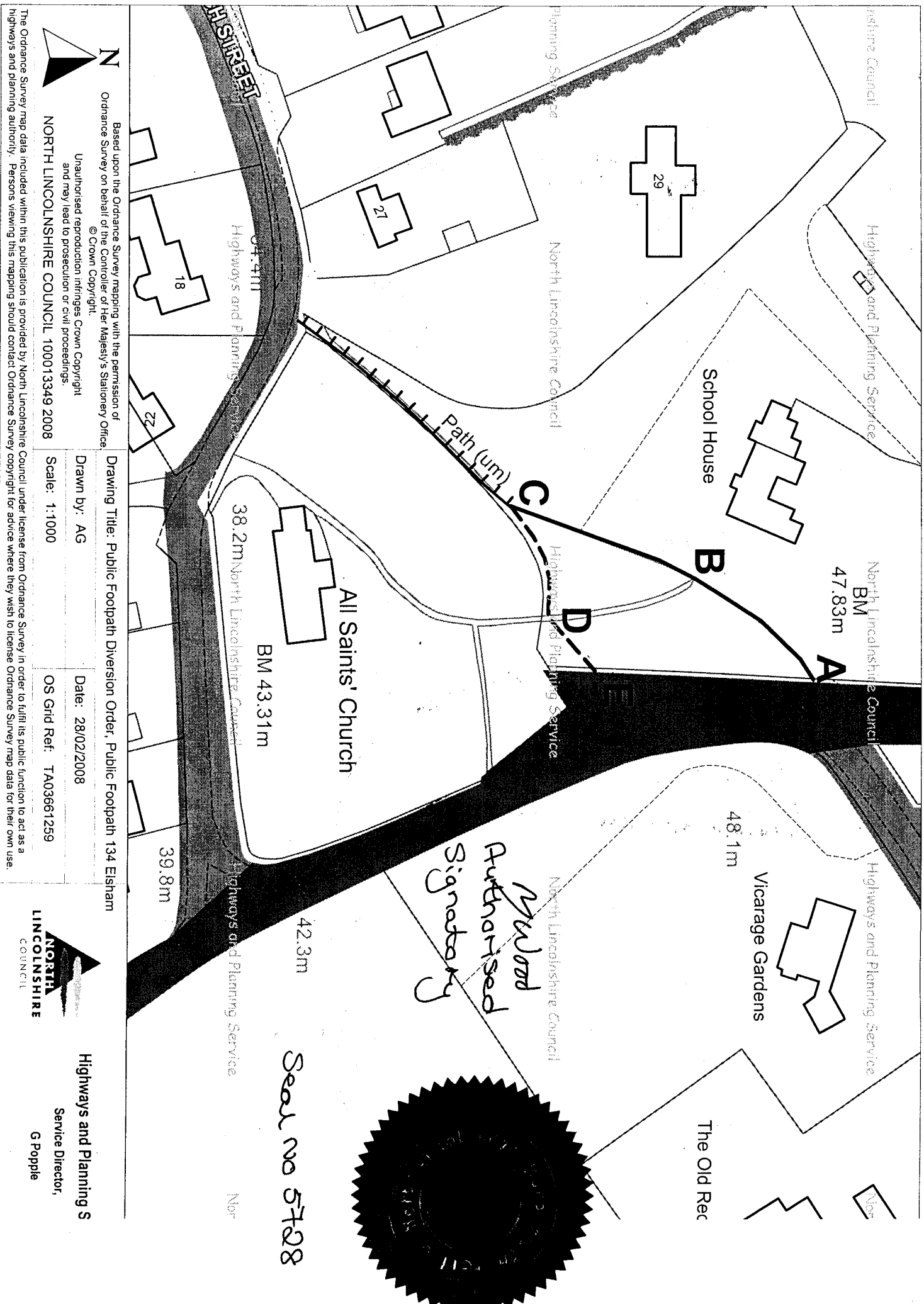
