Definitive Map Modification (Public Footpath 68, Epworth) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle-of-Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 17th February 2005.
2. The County of Lincoln – Parts of Lindsey (Isle-of-Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 68, Epworth) Order 2005(1).



SCHEDULE

PART 1

Modification of Parts of Lindsey (Isle-of-Axholme) Definitive Map

Description of path to be deleted

A – B, as indicated on the map: A 189 metre long footpath commencing at grid reference SE7747603778 and leading east to grid reference SE7766103741.

Description of path to be added

C – D, as indicated on the map: A 198 metre long footpath commencing from Public Footpath 67 at grid reference SE7746403664 and leading east to Public Footpath 66 at grid reference SE7765103641, as indicated on the map. The footpath has a minimum width of 1.5 metres within an area of public open space of a width of at least 5 metres.

PART 2

Modification of Parts of Lindsey (Isle-of-Axholme) Definitive Statement

Variation of particulars of path

A 198-metre-long footpath of 1.5 metres wide within an area of public open space, commencing from Public Footpath 67 at grid reference SE7746403664 and leading east to Public Footpath 66 at grid reference SE7765103641.

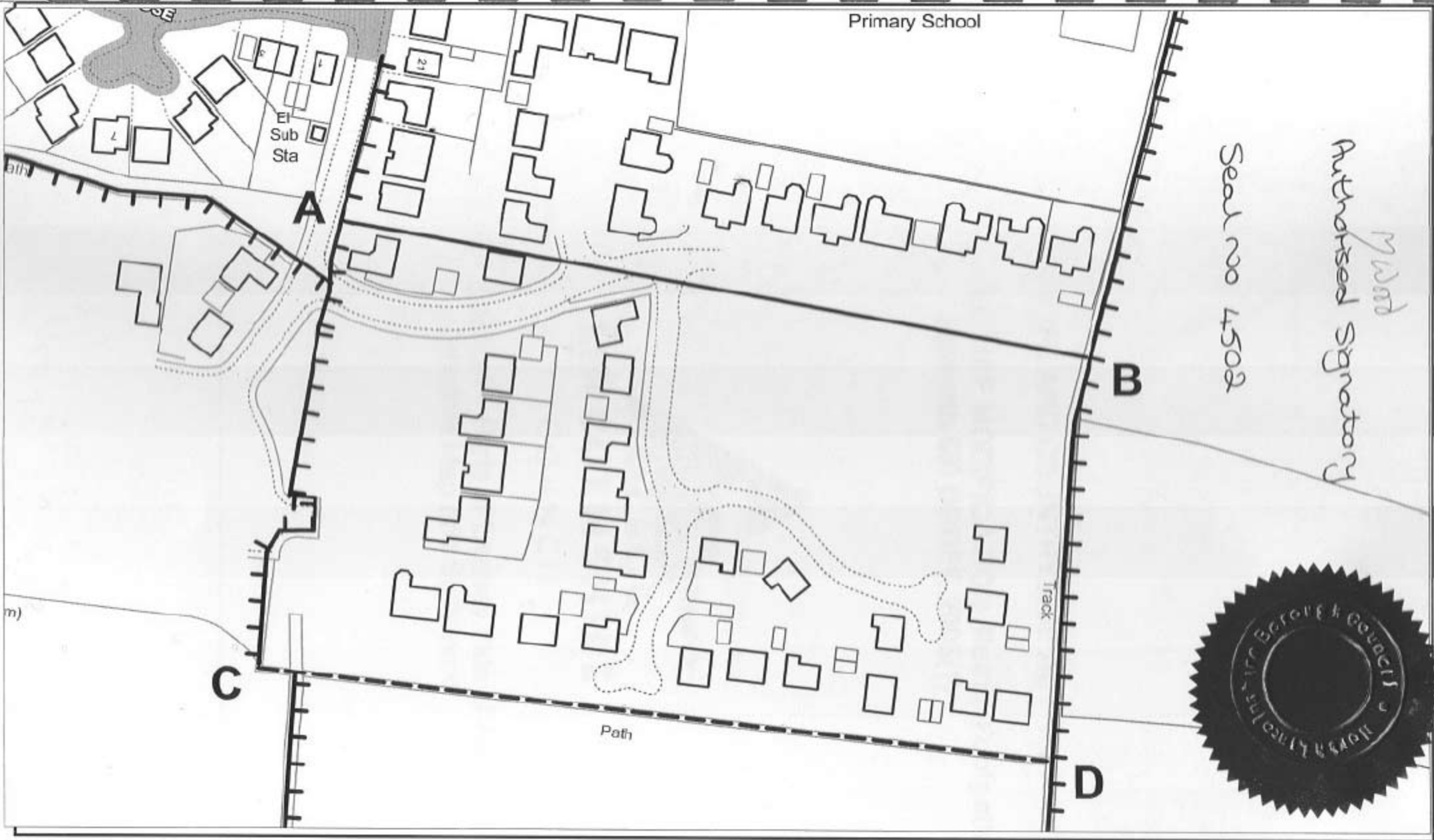
