This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, namely, the coming into operation of any enactment, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 7th October 2004.
2. The County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 71, Epworth) Order 2004(1).

Description of path to be deleted

A – B, as indicated by a solid line on the map: a 255-metre-long footpath of a width of two metres leading in a south-south-easterly direction from grid reference SE7695903600 to and through Skyers Farm to its junction with Public Footpath 65 at grid reference SE7704003356.

Description of path or way to be added

A – C, as indicated by a dashed line on the map: a 171-metre-long footpath leading in an easterly direction from grid reference SE7695903600 to its junction with Public Footpath 70 at grid reference SE7713003608.

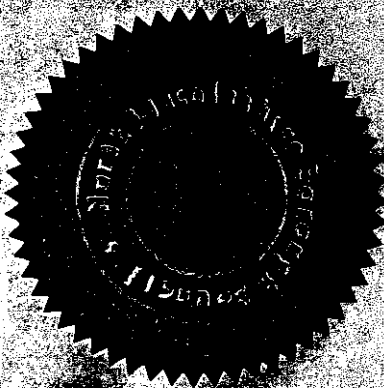

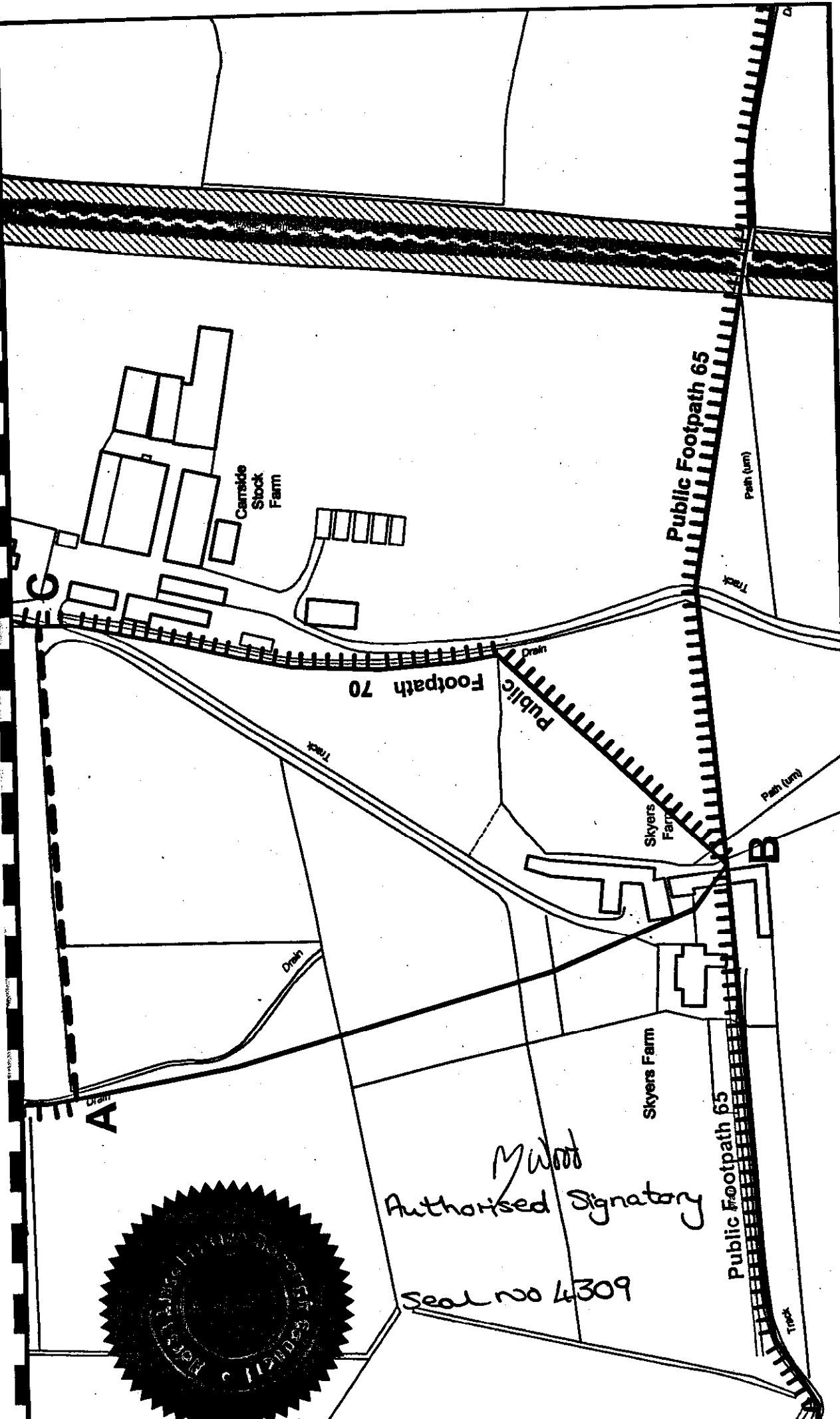
C, as indicated by a dashed line on the map, is a 171-
