"Definitive Map Modification (Public Footpath 49, Epworth) Order 2006(1)"

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

1. For the purposes of this order the relevant date is 17th February 2006.
2. The County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath 49, Epworth) Order 2006(1)".

SCHEDULE

PART 1

Modification of Definitive Map

Description of path or way to be added

A – B, as indicated on the map: A 1.8-metre-wide footpath commencing at a point close to the south-east corner of No. 40B, Station Road, at grid reference SE77510443, and proceeding in a north-westerly direction along the pavement on the northern side of Station Road for 117 metres to a point along Station Road between No. 48A and the old Sunday School at grid reference SE77420450.

B – C, as indicated on the map: A four-metre-wide footpath commencing at a point along Station Road at grid reference SE77420450 and proceeding for 16 metres in a north-easterly direction between No. 48A, Station Road, and the old Sunday School to a point along Public Footpath 49 where Public Footpath 49 makes a right-angled turn to the north west at grid reference SE77430452.

PART 2

Modification of Definitive Statement

Variation of particulars of path or way

A 133-metre-long footpath commencing at a point close to the south-east corner of No. 40B, Station Road, at grid reference SE77510443 and proceeding in a north-westerly direction over a width of 1.8 metres along the pavement on the northern side of Station Road to a point along Station Road at grid reference SESE77420450 between No. 48A, Station Road, and the old Sunday School; and thence continuing in a north-easterly direction for 16 metres to the point at which Public Footpath 49 makes a right-angled turn to the north west at grid reference SE77430452.

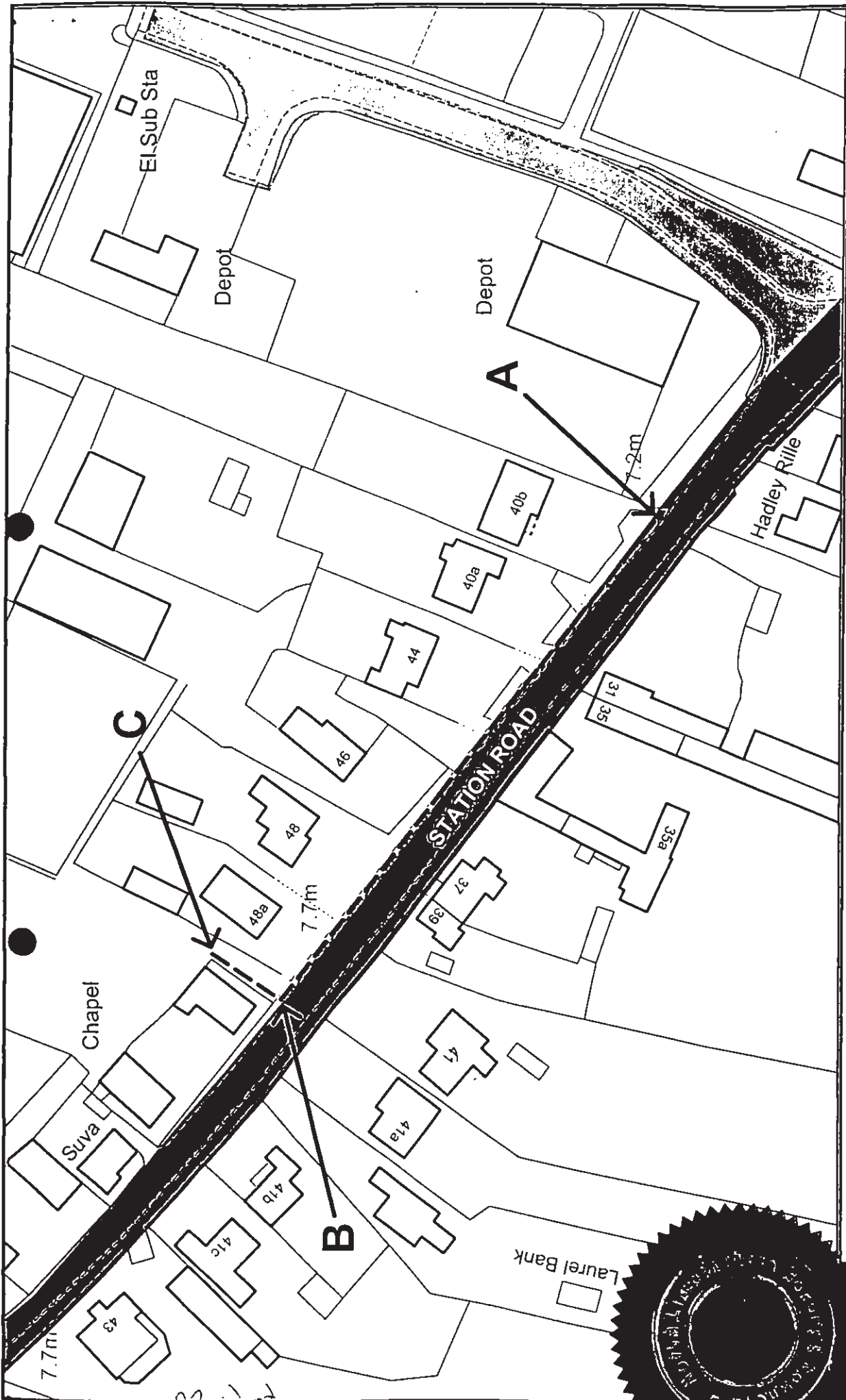
