Definitive Map Modification (Public Footpath 177, Flixborough) Order 2003(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authorities have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 19th September 2003.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 177, Flixborough) Order 2003(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A 408-metre-long footpath commencing at grid reference SE87751434 (Point A) and leading across land situated at Normandby Enterprise Park generally south-westwards to grid reference SE87581403 (Point F), as indicated on the map.

Description of path to be added

A 475-metre-long footpath commencing at grid reference SE87751434 (Point A) and following the south side of a fence line in a generally westerly direction for 120 metres to grid reference SE87641431 (Point B), continuing along the east side of a fence line in a generally south-south-easterly direction for 203 metres to grid reference SE87691411 (Point C), then crossing scrubland in a south-westerly direction for 29 metres to grid reference SE87671408 (Point D), then along the north side of the perimeter fence in a generally westerly direction for 90 metres to grid reference SE87591406 (Point E), continuing along the west side of a perimeter fence in a generally southerly direction for 30 metres to grid reference SE87581403 (Point F), as indicated on the map. The footpath has a minimum width of 1.5 metres.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement
Variation of particulars of path

A 475-metre-long footpath commencing at grid reference SE87751434 north-east of the grave yard of All Saints Church and following the south side of a fence line in a generally westerly direction for 120 meters to grid reference SE87641431, continuing along the east side of a fence line in a generally south-south-easterly direction for 203 metres to grid reference SE87691411, then crossing scrubland in a south-westerly direction for 29 metres to grid reference SE87671408, then along the north side of the perimeter fence in a generally westerly direction for 90 metres to grid reference SE87591406, continuing along the west side of a perimeter fence in a generally southerly direction for 30 metres to join Public Footpath 175 at grid reference SE87581403. The footpath has a minimum width of 1.5 metres throughout.

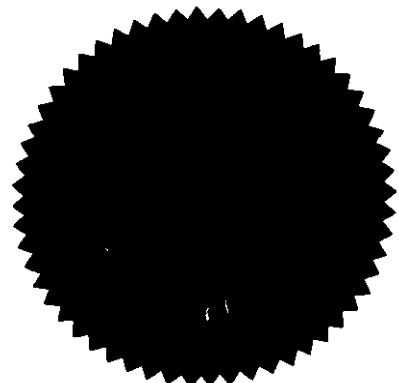

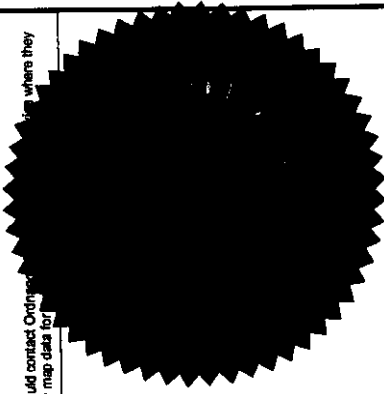


A4 Plotter Frame
