County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

Definitive Map Modification Order (Public Footpath 62A Goxhill) 2010 (1)

This order is made by North Lincolnshire Council under section 53(2) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) – namely a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

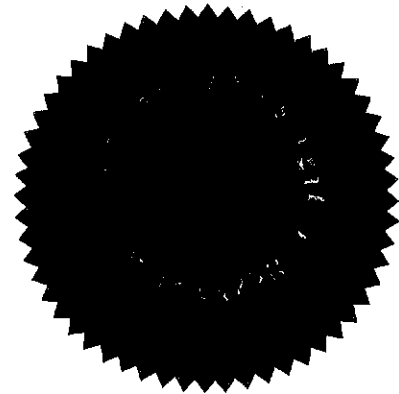
1. For the purpose of this order the relevant date is 20th April 2010.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 62A, Goxhill) Order 2010 (1)

PART I

Modification of County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path or way to be added

A – B as indicated on the map: A 66-metre-long footpath commencing at grid reference TA10442185 at a point adjoining the existing public footpath 62, running north-westerly field edge to grid reference TA10402190.

B – C as indicated on the map: A 17-metre-long footpath commencing at grid reference TA10402190 and running cross field west-south-westerly to it's junction with public footpath 62 at grid reference TA10392189.

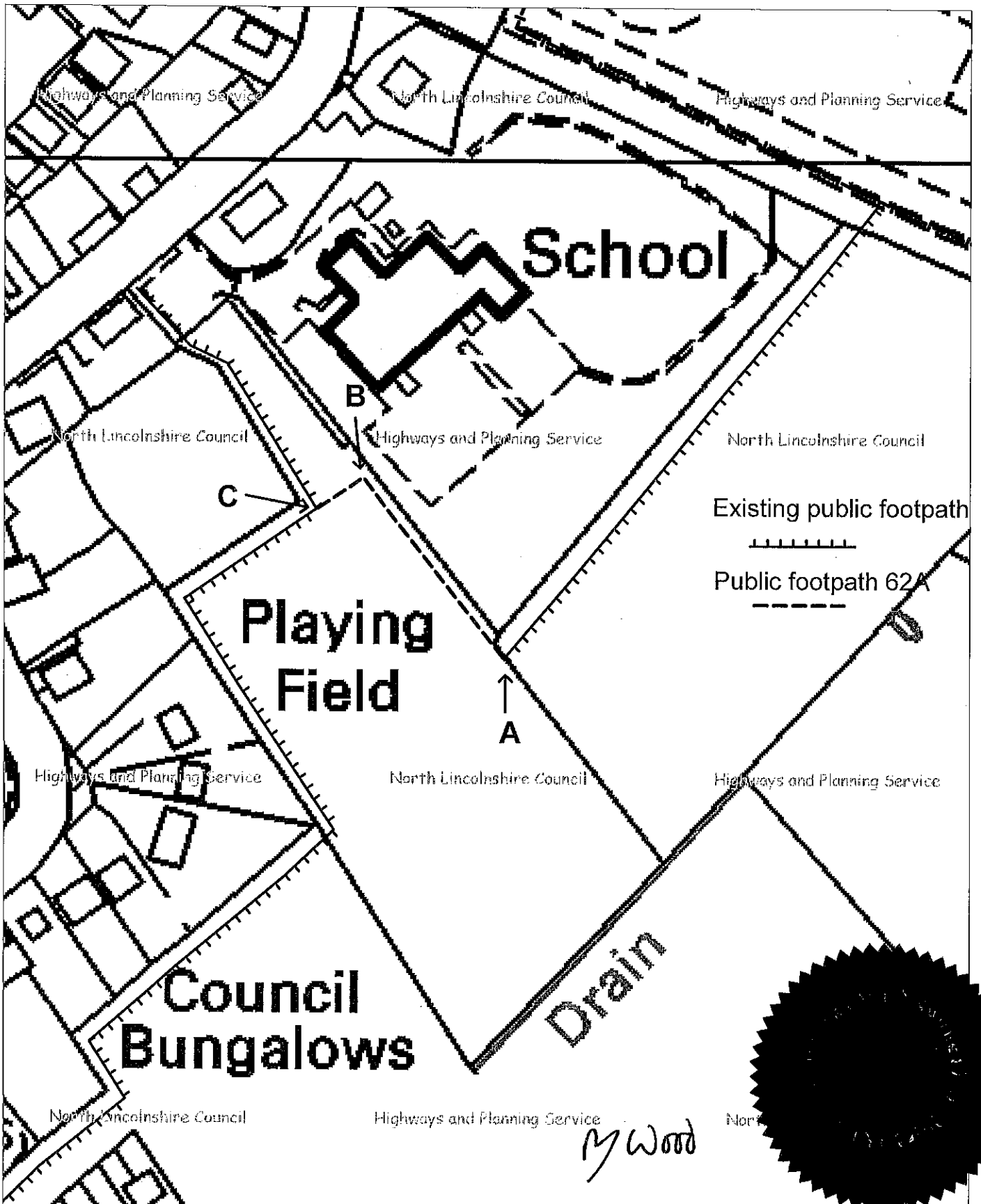

Variation of particulars of the path

An 83-metre-long footpath commencing at a point adjoining public footpath 62 at grid reference TA10442185 leading in a north-westerly direction along the field edge to grid reference TA10402190 where it leads in a west-south-westerly direction cross field to it's junction with public footpath 62 at grid reference TA10392189.
