## **Wildlife and Countryside Act 1981**

### **County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement**

#### **"Definitive Map Modification (Public Footpath 63a, Goxhill) Order 2006(1)"**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) - namely, the coming in to operation of any enactment or instrument, or any other event, whereby a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path - of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 28<sup>th</sup> September 2006.
2. The County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath 63a, Goxhill) Order 2006 (1)".

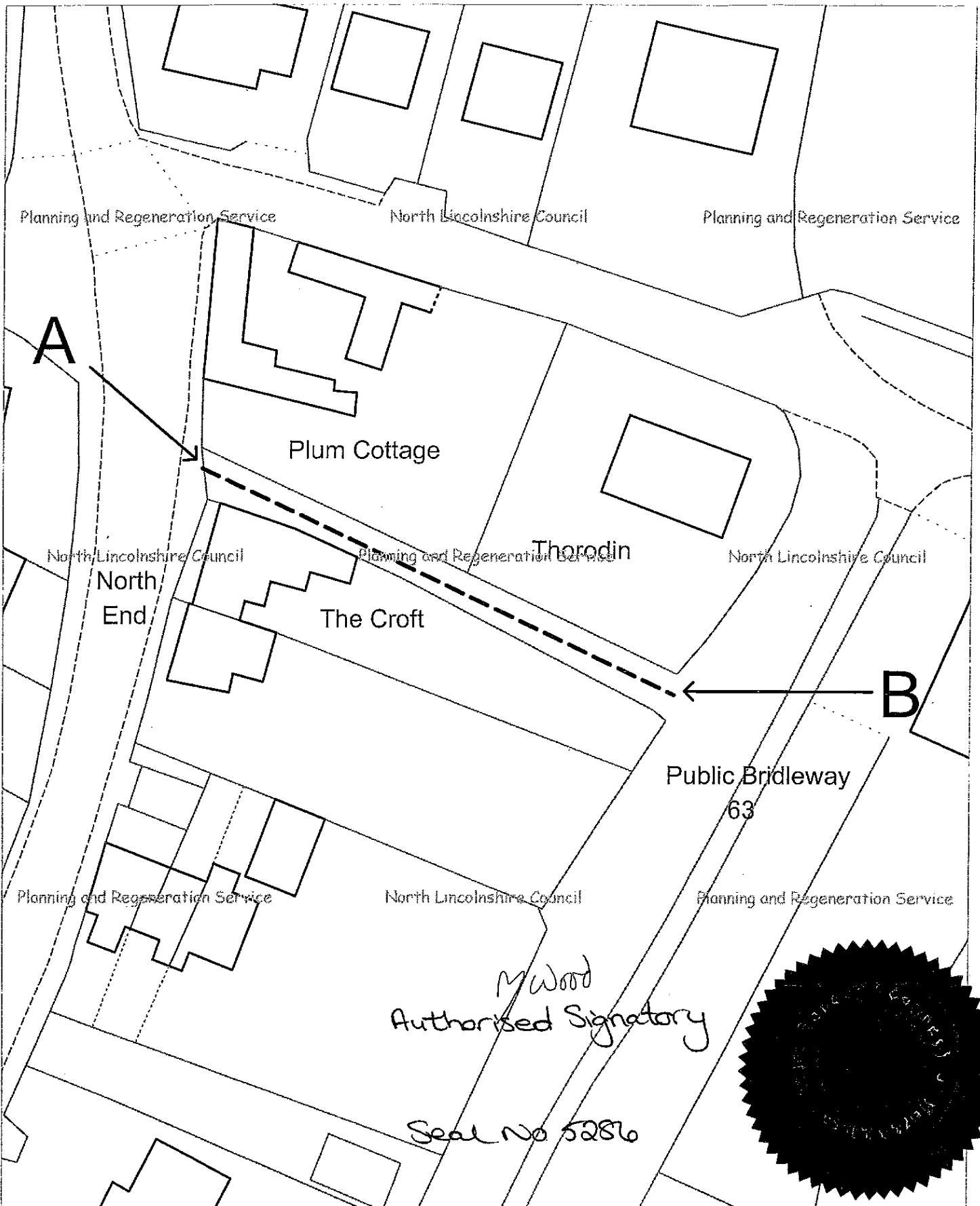

###### **Modification of Parts of Lindsey (Glanford Brigg) Definitive Map**

###### **Description of path to be added**

A - B, as indicated on the map: A 51-metre-long public footpath commencing on North End at grid reference TA1058622428 and proceeding between "The Croft" to its south and "Plum Cottage" and "Thorodin" to its north in a south-easterly direction to grid reference TA1063222406.

The footpath has a width of 2 metres throughout and runs between the northern boundary of "The Croft" and the southern boundaries of "Plum Cottage" and "Thorodin".
