Definitive Map Modification (Public Footpath 72, Goxhill) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3rd May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 72, Goxhill) Order 2005(1).

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 223-metre-long footpath commencing at the south-east corner of O.S. Field number 5236 at grid reference TA1272022219, and then along the southern boundary of a hedgerow belonging to a property known as Chapel Farm in a easterly direction to the south-east boundary of the same property at grid reference TA1283022206, and then across a field in a easterly direction crossing a 4 metre footbridge before joining the existing footpath at the Goxhill / East Halton Parish Boundary at grid reference TA1293622231. The footpath has a minimum width of 1.25 metres throughout.

Description of path to be deleted

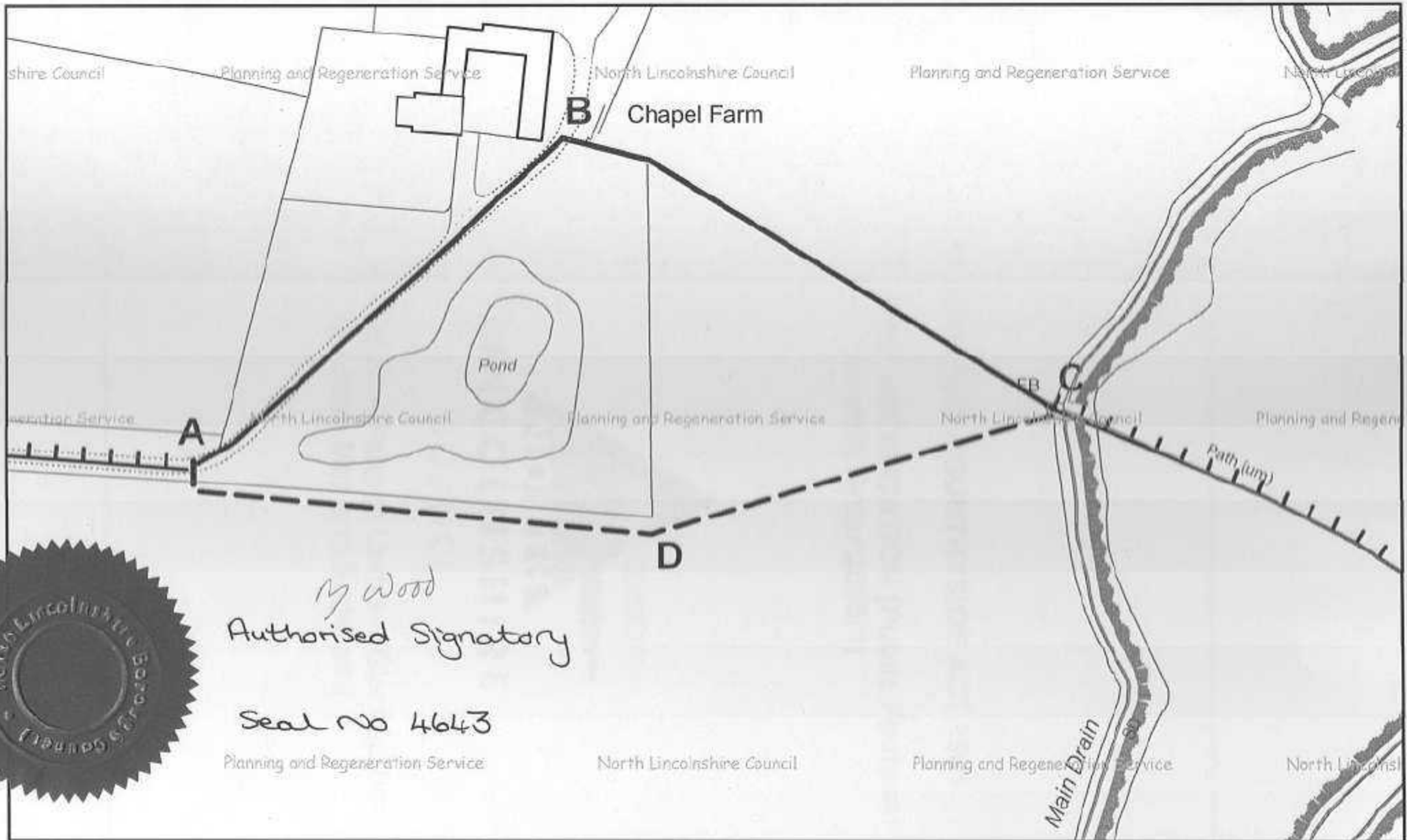
A – B as indicated on the map: A 119-metre-long footpath commencing at the south-east corner of O.S. Field number 5236 at grid reference TA1272022219, proceeding in a north-easterly direction to the south-eastern corner of Chapel Farm at grid reference TA1280822297.

B – C as indicated on the map: A 145-metre-long footpath commencing at the south-east corner of Chapel Farm at grid reference TA1280822297, proceeding in a south-easterly direction to the Goxhill / East Halton Parish Boundary at grid reference TA1293622231.

Description of path to be added

A – D as indicated on the map: A 113-metre-long footpath with a width of 1.25 metres commencing at the south-east corner of O.S. Field number 5236 at grid reference TA1272022219, proceeding along the southern boundary of a hedgerow belonging to a property known as Chapel Farm in a easterly direction to the south-east boundary of the same property at grid reference TA1283022206.

D – C as indicated on the map: A 110-metre-long footpath with a width of 1.25 metres commencing at the south-east boundary of a property known as Chapel Farm at grid reference TA1283022206, proceeding across a field in a easterly direction crossing a 4 metre footbridge before joining the existing footpath at the Goxhill / East Halton Parish Boundary at grid reference TA1293622231.
