Wildlife and Countryside Act 1981

County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

"Definitive Map Modification (Public Footpath, Goxhill 56) Order 2007 (1)"

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(iii) – namely, "the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification" of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 2nd April 2007.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Definitive Map Modification (Public Footpath, Goxhill 56) Order 2007 (1)".

SCHEDULE

PART I

Modification of Definitive Map

Description of path or way to be deleted

A – B, as indicated on the map: A 292-metre-long rectilinear footpath commencing at a point on Gatehouse Road opposite Crossing Cottage at grid reference TA10112074 and proceeding in a south-south-westerly direction over a defined track, first along the western side of Gatehouse Farm and then onwards to Hallands Field Farm, to a further point at grid reference TA10032046, this

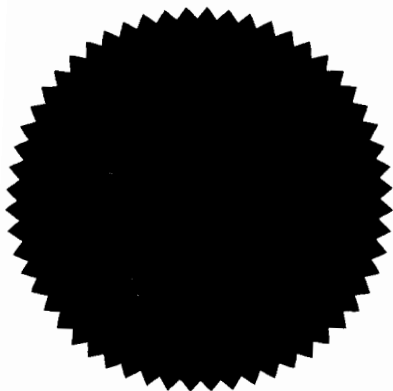
being 8 metres north-west of the north-western corner of the collection of buildings that comprise Hallands Field Farm.

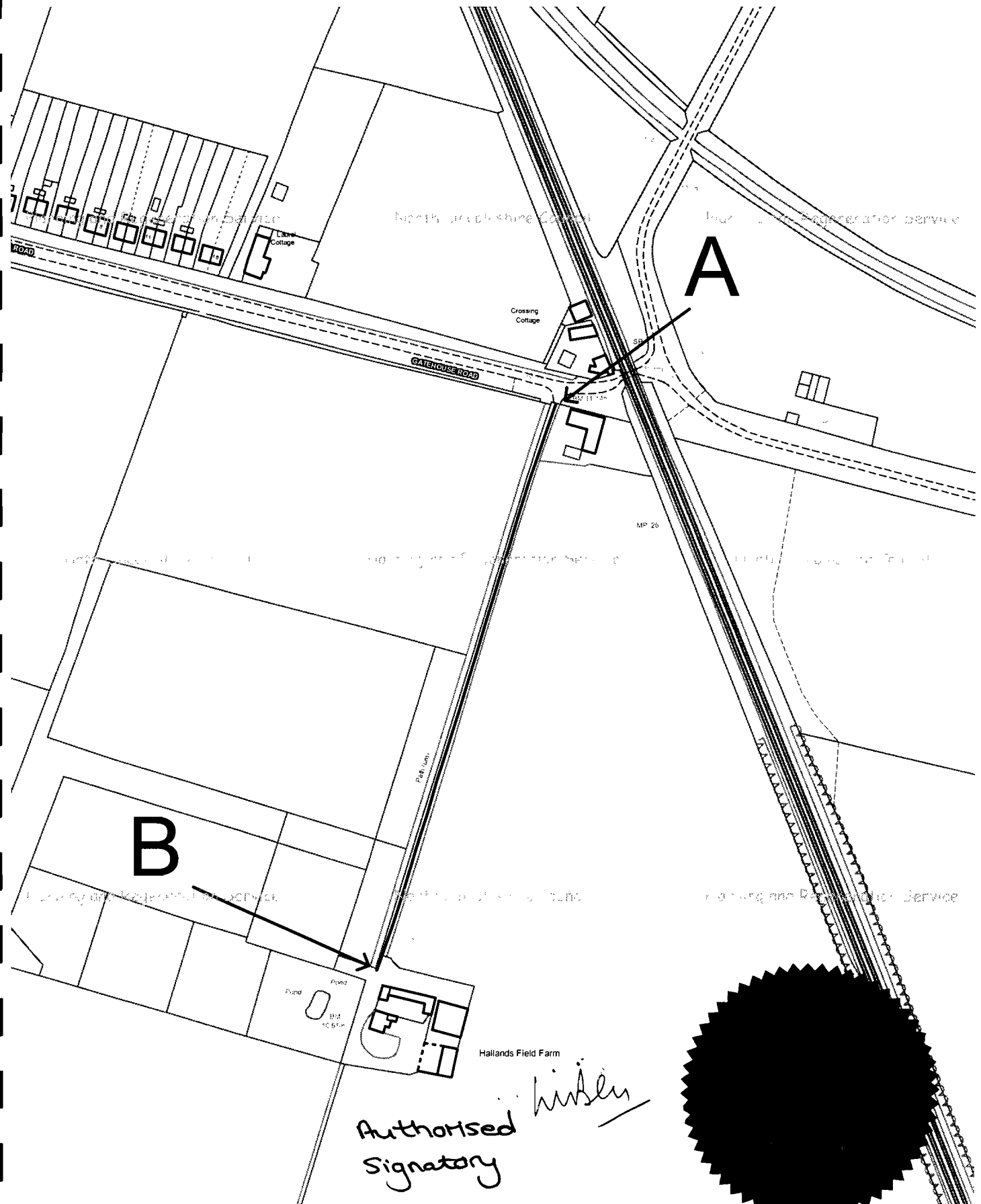
