**Definitive Map Modification (Public Footpath 242, Manton) Order 2005(1)**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 242, Manton) Order 2005(1).

**PART 1**

**Modification of Parts of Lindsey (Glanford Brigg) Definitive Map**

*Description of path to be deleted*

A – B, as indicated on the map: A 101.2-metre-long footpath commencing at grid reference SE9331002523 that runs across the frontage of a property known as "School House" in a north-easterly direction to grid reference SE9334802611.

*Description of path to be added*



C – D, as indicated on the map: A 66.9-metre-long footpath with a width of 1.25 metres commencing at grid reference SE9335402537 and proceeding along the eastern side of a fence which marks the boundary of a property known as "School House" in a north-north-easterly direction to grid reference SE9337202601.

D – B, as indicated on the map: A 27.6-metre-long footpath with a width of 1.25 metres commencing at grid reference SE9337202601 and proceeding along the northern side of a fence which marks the boundary of the property known as "School House" in a north-westerly direction to grid reference SE9334802611.

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

*Variation of particulars of path*

A 94.5-metre-long footpath commencing at grid reference SE9335402537 and proceeding through a hand-gate and following the eastern side of a fence which marks the boundary of the property known as "School House" in a north-north-easterly direction to grid reference SE9337202601, and then along the northern side of a fence which marks the boundary of a property known as "School House" in a north-westerly direction to grid reference SE9334802611. The footpath has a minimum width of 1.2 metres throughout.
