**Definitive Map Modification (Public Footpath 242, Manton) Order 2005(2)**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 242, Manton) Order 2005(2).

**PART 1**

**Modification of Parts of Lindsey (Glanford Brigg) Definitive Map**

*Description of path to be deleted*

A – B, A 50.1-meter-long footpath commencing at grid reference SE9329202728 proceeding from a point 14 metres to the south-west of the entrance to the property known as "Brodian Lodge" in a south-easterly direction for 20 metres and then in an easterly direction for 30.1 metres to a point 56 metres north west of St Hibald's Church to grid reference SE9334302712, as indicated on the map.



*Description of path to be added*

C – B, A 42-metre-long footpath with a width of 3 metres commencing at grid reference SE9329802730 proceeding from a point 10 metres to the south-west of the entrance to the property known as "Brobian Lodge" in a south-easterly direction to a point 56 metres north-west of St Hibald's Church to grid reference SE9334302712, as indicated on the map.

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

*Variation of particulars of path*

A 42-metre-long footpath with a width of 3 metres commencing 10 metres to the south-west of the entrance to the property known as "Brobian Lodge" at grid reference SE9329802730 proceeding in a south-easterly direction up the driveway of the property known as "The Orchard" to a point 56 metres north-west of St Hibald's Church and the existing footpath at grid reference SE9330602713.
