County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

Definitive Map Modification (Public Footpath 244, Manton) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 10th January 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 244, Manton) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B: A 540-metre-long footpath commencing at grid reference SE9233501375 that runs diagonally across a field in a south-easterly direction to grid reference SE9283801126 as indicated on the map.

Description of path to be added

A – C: A 235-metre-long footpath with a width of 1.5m commencing at grid reference SE9233501375 and following the northern side of a drain between the bank of a reservoir and a row of poplar trees in a easterly direction to the pump house to grid reference SE9254501363, as indicated on the map.

C – D: A 518-metre-long footpath with a width of 1.5m commencing at grid reference SE9254501363 and following the northern boundary of a field in a easterly direction, and then following the eastern boundary of the same field in a southerly direction to the junction with footpath 245 at grid reference SE9297801187, as indicated on the map.

D – E: A 132-metre-long footpath with a width of 1.5m commencing at grid reference SE9297801187 and following the eastern boundary of the same field in a southerly direction to grid reference SE9299301062, as indicated on the map.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 885-metre-long footpath commencing on the B1400 Manton Road crossing a culvert at the field entrance at grid reference SE9233501375 and following the northern side of a drain between the bank of a reservoir and a row of poplar trees in a easterly direction to the pump house to grid reference SE9254501363, and then crossing a 4m footbridge following the northern boundary of a field and the southern boundary of a drain in a easterly direction, and then following the eastern boundary of the same field and the western boundary of a drain to the junction with footpath 245 at grid reference SE9297801187, and then following the eastern boundary of the same field and the western side the same drain in a southerly direction to join the minor road near property known as The Square at grid reference SE 9299301062. The footpath has a minimum width of 1.5 metres throughout.

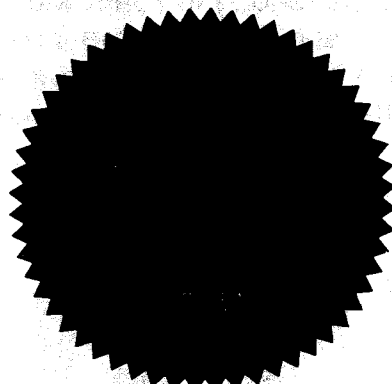

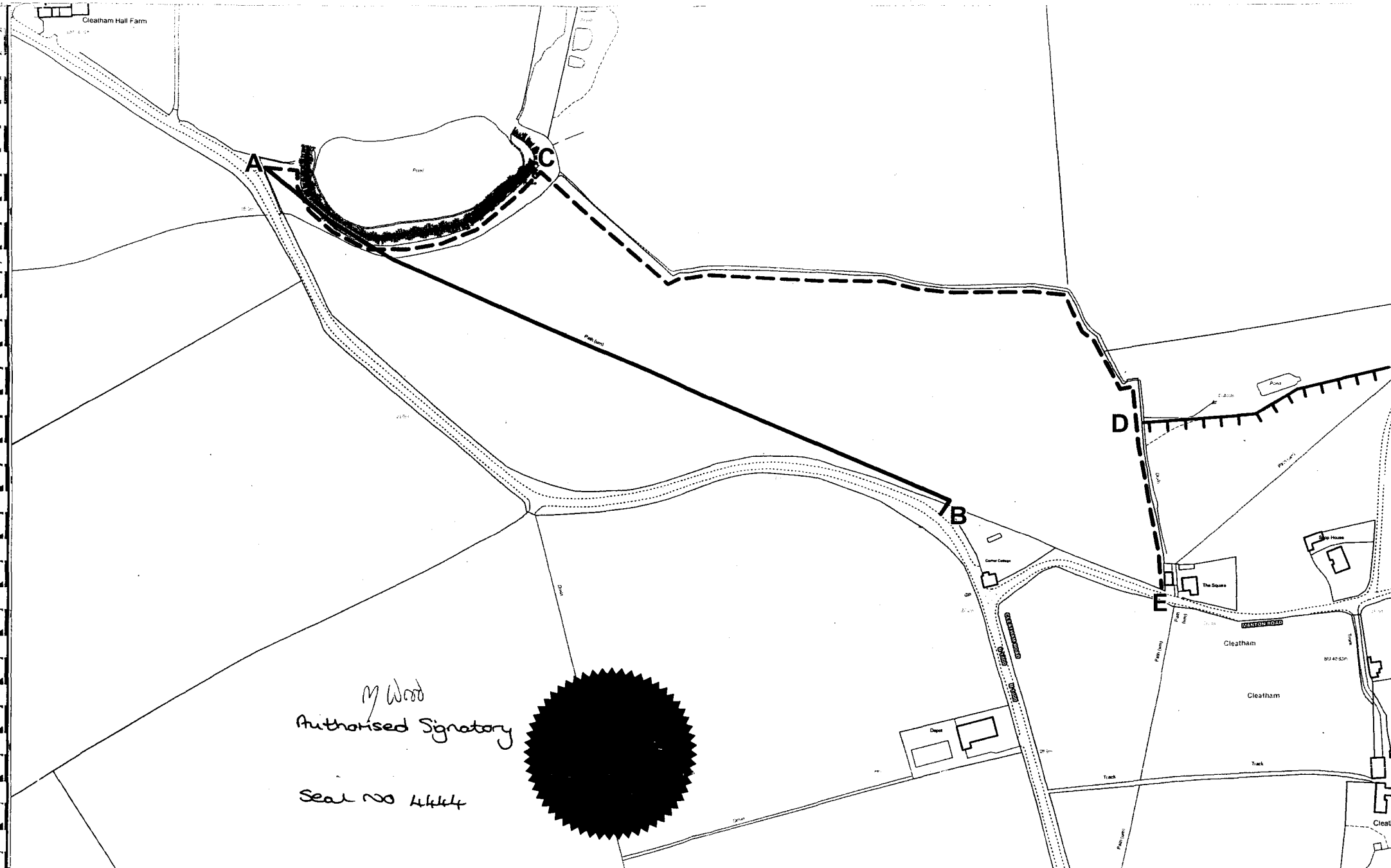
