## Wildlife and Countryside Act 1981

### County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

#### Definitive Map Modification (Public Footpath 202 Messingham) Order 2007(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) - namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended - of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 29<sup>th</sup> June 2007.
2. The County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 202, Messingham) Order 2007(1).

#### SCHEDULE

##### PART 1

#### Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

##### Description of path to be deleted

*Point A—B as indicated on the map:* a 224-metre-long footpath commencing at the eastern end of Butterwick Road at grid reference SE88150426 and proceeding in a south-westerly direction diagonally first over a field, then across the gardens of two properties known as Four Winds and Shraheen House, and then across a further part of the same arable field as at its

commencement to a point at the south-western corner of the said field at grid reference SE88020408.

*Point B—C as indicated on the map:* an 18-metre-long footpath commencing at the south-western corner of an arable field situated south west of the junction of Butterwick Road and North Moor Road at grid reference SE88020408 and proceeding in a southerly direction across an east-to-west drain into an area of woodland, and then along the western side of a drain to a point at grid reference SE88020406.

*Point C—D as indicated on the map:* a 178-metre-long footpath commencing some 18 metres south of the north-eastern corner of an area of woodland at grid reference SE88020406 and proceeding in a south-westerly direction diagonally across an area of woodland to a point on the western boundary of the said wood at grid reference SE87880396.

*Point D—E as indicated on the map:* a 329-metre-long footpath commencing on the western boundary of an area of woodland at grid reference SE87880396 and proceeding in a south-westerly direction diagonally across a section of track and then across an area of fishing ponds to a point on a further track at the south-western corner of the said fishing ponds at grid reference SE87620376.

*Point E—F as indicated on the map:* a 179-metre-long footpath commencing on a track at the south-western corner of a fishing pond at grid reference SE87620376 and proceeding in a south-south-westerly direction across a golf course in the ownership of Grange Park to the junction with Black Bank Road at grid reference SE87540360.

#### Description of path to be added

*Point G—B as indicated on the map:* a 186-metre-long footpath of a width of 1.8 metres commencing on Butterwick Road at grid reference SE87990426 and proceeding in a southerly direction along the eastern boundary of an arable field to a point at the south-eastern corner of the said field at grid reference SE88020408.

*Point B—H as indicated on the map:* a 160-metre-long footpath of a width of 1.8 metres commencing at a point at the south-eastern corner of an arable field at grid reference SE88020408 and proceeding in a westerly direction along the southern boundary of the said arable field and the northern side of a drain, to a point at the south-western corner of the said field at grid reference SE87860409.

*Point H—D as indicated on map:* a 131-metre-long footpath of a width of 1.8 metres commencing at the south-western corner of an arable field at grid

reference SE87860409 and proceeding in a southerly direction firstly over a footbridge crossing an east-to-west drain and then along the western boundary of an area of woodland to a point on the western boundary of the said wood at grid reference SE87880396.

*Point D—l as indicated on the map:* a 380-metre-long footpath of a width of 1.8 metres commencing on the western boundary of an area of woodland at grid reference SE87880396 and proceeding in a southerly direction firstly through a gap in the wood onto a track at the eastern side of an area of fishing ponds and then along the said track and then along the eastern boundary of an area of open scrubland in the ownership of Messingham Parish Council to its junction with Black Bank Road at grid reference SE87940358.

## PART 2


### Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

#### Variation of particulars of path

An 857-metre-long footpath commencing on Butterwick Road at grid reference SE87990426 and proceeding in a southerly direction along the eastern boundary of an arable field to a point at the south-eastern corner of the said field at grid reference SE88020408, and then proceeding in a westerly direction along the southern boundary of the same arable field and the northern side of a drain, to a point at the south-western corner of the said field at grid reference SE87860409, and then proceeding in a southerly direction firstly over a six metre footbridge crossing an east-to-west drain and then along the western boundary of an area of woodland to a point on the western boundary of the said wood at grid reference SE87880396, and then proceeding in a southerly direction firstly through a gap in the wood onto a track at the eastern side of an area of fishing ponds and then along the said track, proceeding along the eastern boundary of an area of open scrubland in the ownership of Messingham Parish Council to its junction with Black Bank Road at grid reference SE87940358.

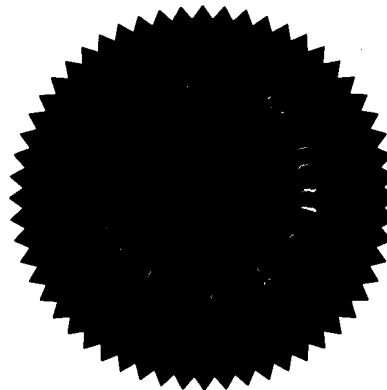

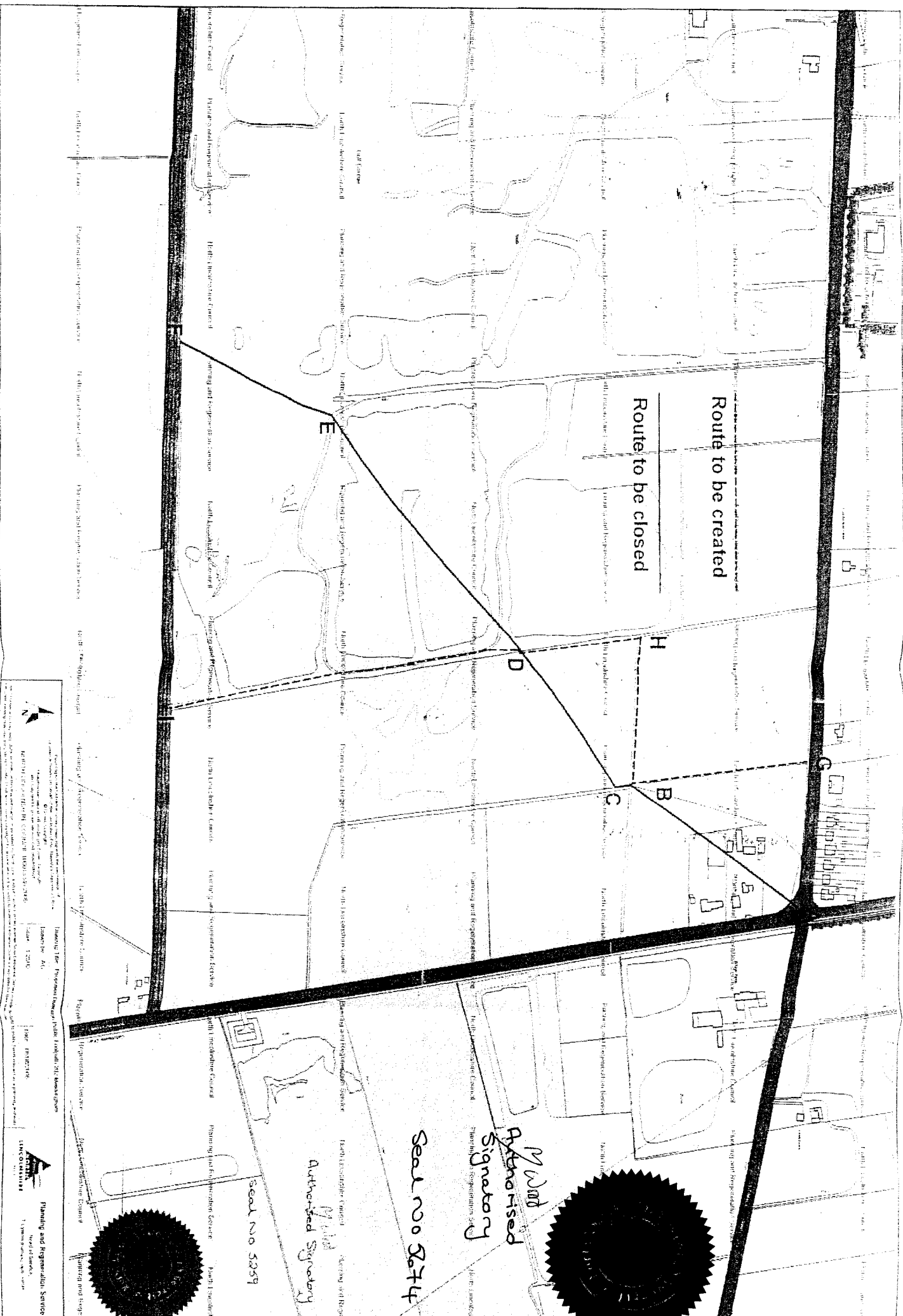

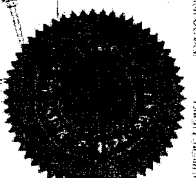
