Definitive Map Modification (Public Footpath 264, Redbourne) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 264, Redbourne) Order 2005(1).

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 548-metre-long footpath commencing at the junction of Vicarage Lane and the B1206 at grid reference SK9719699832, proceeding along Vicarage Lane in an easterly direction to the eastern end of Vicarage Lane at grid reference SK 9732299855, and then crossing a playing area in a first north-easterly, then northerly direction to the southern entrance of Redbourne churchyard at grid reference SK9733499906, and then along the southern boundary of the churchyard in an easterly direction to a kissing gate at the eastern boundary of the churchyard at grid reference SK 9737699917, and then along the east side of the church wall in a northerly direction to grid reference SK9737599922, and then along the south side of a fence belonging to a property known as Castle Keep in an easterly direction before proceeding across a field again in an easterly direction to grid reference SK9767999956 and 50 metres join the existing public footpath at grid reference SK9770099893. The footpath has a minimum width of 1.5 metres throughout.

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B, as indicated on the map: A 383-metre-long footpath commencing at grid reference SK9732299855 at the eastern end of Vicarage Lane proceeding in front of the Old Vicarage and then across a field in an easterly direction to join the existing public footpath at grid reference SK9769799889.

Description of path to be added

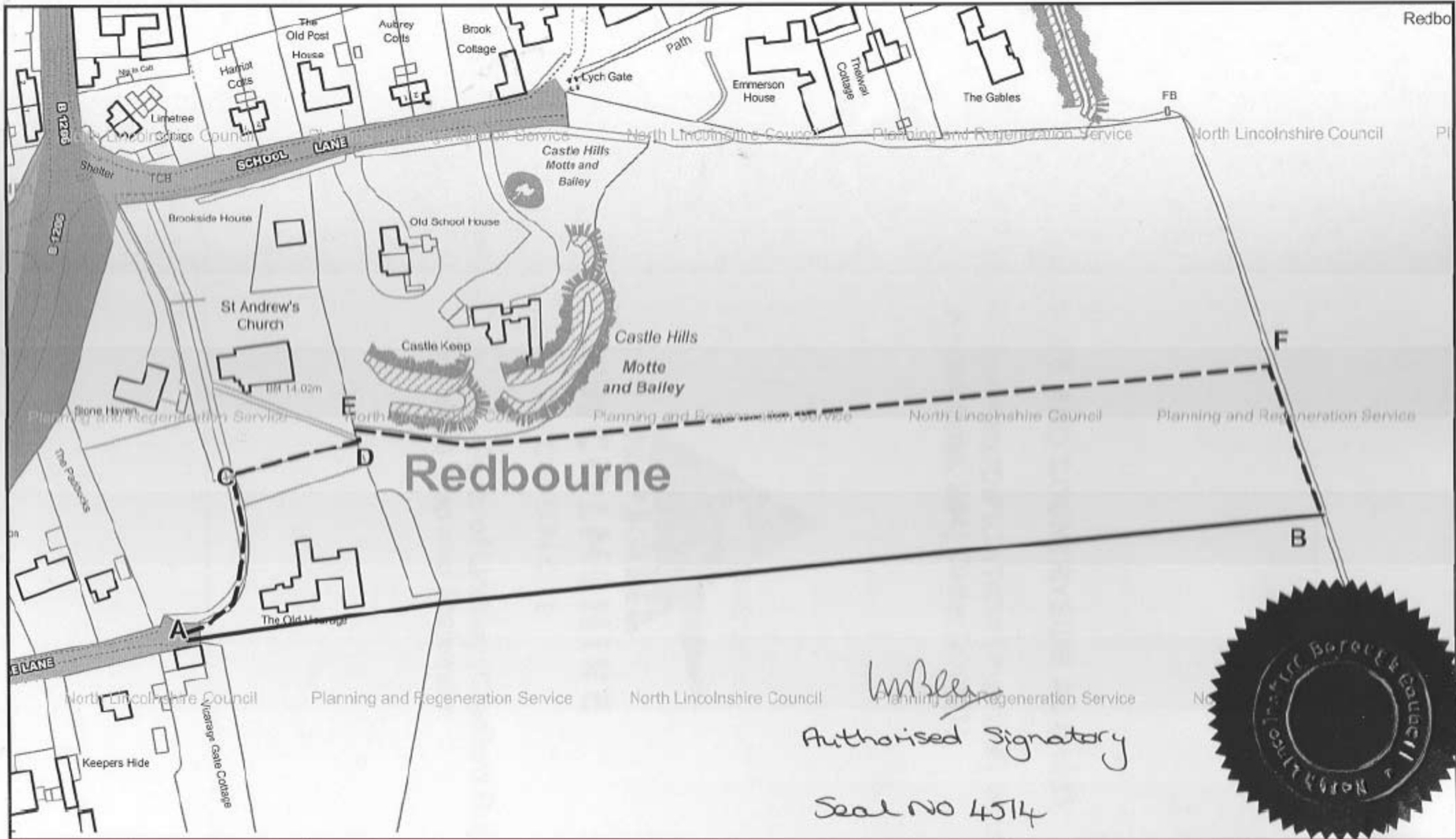
A – C, as indicated on the map: A 60-metre-long footpath with a width of 1.5 metres commencing at grid reference SK9732299855 at the eastern end of Vicarage Lane proceeding across a play area in a first north-easterly, then northerly direction to grid reference SK9733499906.

C – D, as indicated on the map: A 44-metre-long footpath with a width of 1.5 metres commencing at grid reference SK9733499906, at the southern entrance into Redbourne churchyard and proceeding along the southern boundary of the churchyard in an easterly direction to a kissing gate at grid reference SK9737699917.

D – E, as indicated on the map: A 7-metre-long footpath with a width of 1.5 metres commencing at grid reference SK9737699917, at a kissing gate at the eastern end of Redbourne churchyard proceeding on the eastern side of the church wall in a northerly direction to grid reference SK9737599922.

E – F, as indicated on the map: A 310-metre-long footpath with a width of 1.5 metres commencing at grid reference SK9737599922, at the north-west corner of a field proceeding first along the southern boundary fence of a property known as Castle Keep then across a field in an easterly direction to join the existing public footpath at grid reference SK9767999956, some 50 metres north of the original point.

F – G, as indicated on the map: A 50-metre-long footpath with a width of 1.5 metres commencing at grid reference SK9767999956, proceeding in a southerly direction along the western side of the eastern boundary of the field to rejoin the original route at grid reference SK9770099893.
