Definitive Map Modification (Public Footpath 24, South Ferriby) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3rd May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 24, South Ferriby) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 476-metre-long footpath commencing on Winteringham Road some 62 metres west of the bridge over the River Ancholme at grid reference SE9744221068, proceeding over a field in a south-westerly direction to a point on the existing footpath at grid reference SE9724020670.

Description of path to be added

A – C as indicated on the map: A 39-metre-long footpath with a width of four feet commencing on Winteringham Road some 62 metres west of the bridge over the River Ancholme at grid reference SE9744221068, proceeding along a track to the bank of the River Ancholme in a south-easterly direction to grid reference SE9745621034.

C – D as indicated on the map: A 389-metre-long footpath with a width four feet commencing at grid reference SE9745621034, proceeding along the western bank of the River Ancholme in a southerly direction to grid reference SE9740720655.

D – B as indicated on the map: A 161-metre-long footpath with a width of four feet commencing at grid reference SE9740720655, proceeding across a field in a westerly direction to join the existing footpath at grid reference SE9724020670.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Variation of particulars of path

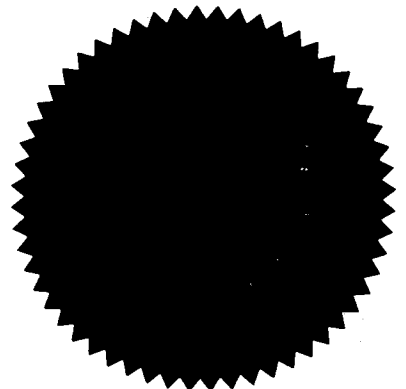
A 589-metre-long footpath commencing on Winteringham Road some 62 metres west of the bridge over the River Ancholme at grid reference SE974421068, proceeding along a 5 metre track and the north eastern side of a steel boundary fence belonging to the Cement Works in a south-easterly direction to the southern end of the track and the western bank of the River Ancholme at grid reference SE9745621034, and then along the western bank of the River Ancholme and the eastern side of a row of trees in a southerly direction to grid reference SE9740720655, and then across a field in a westerly direction to join the existing footpath midway along the southern side of a steel boundary fence belonging to the Cement Works at grid reference SE9724020670. The footpath has a minimum width of four feet throughout.

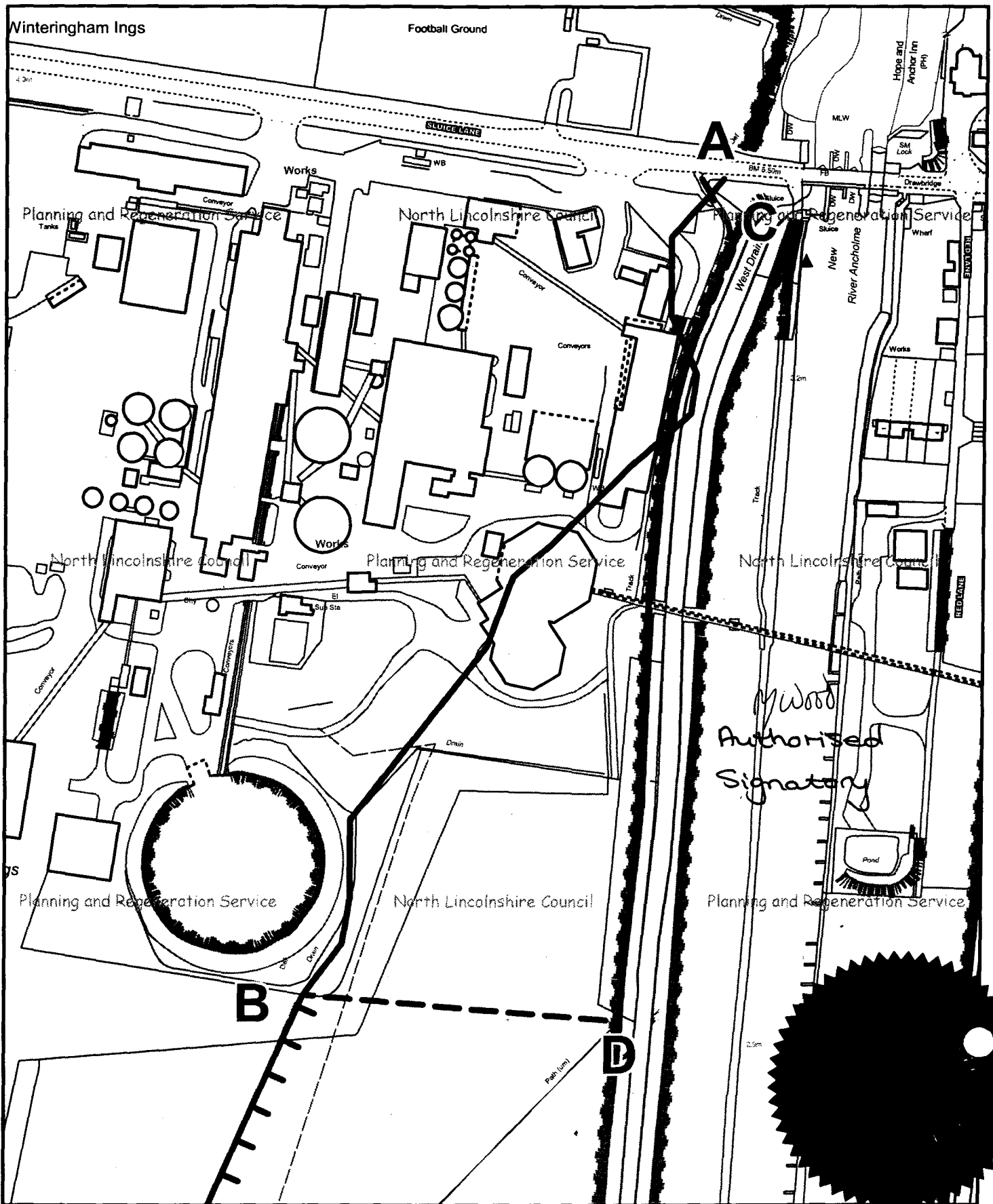
