This order is made by North Lincolnshire Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the public it is expedient that the line of the path should be diverted.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

**BY THIS ORDER**

1. The public right of way over the land situated at South Ferriby and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 10 days from the date of confirmation of this order, and thereupon the "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive map shall be modified by deleting from it that public right of way.
2. There shall at the end of 10 days from the date of confirmation of this order be a public footpath over the land situate at South Ferriby described in Part 2 of the Schedule and shown by a bold black broken line on the map attached to this order and thereupon the "County of Lincoln, parts of Lindsey (Glanford Brigg)" definitive map shall be modified by adding that path to it.
3. The "County of Lincoln, Parts of Lindsey (Glanford Brigg)" definitive statement shall be modified as described in Part 3 of the Schedule to this order.

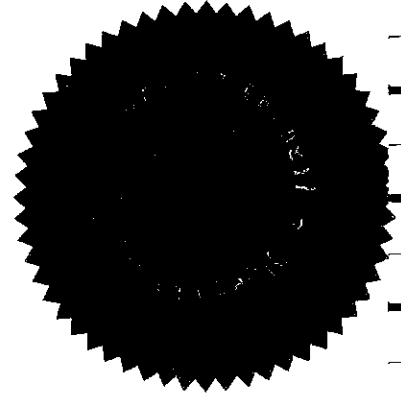

**SCHEDULE**

**PART 1**

**Description of site of existing path**

*Point A—B as indicated on the map:* a 110-metre-long footpath commencing at grid reference SE99482189 at a point on the existing public footpath and the north-western corner of a small quarry and proceeding in a north-westerly direction over a mound of earthwork to the cliff top at grid reference SE99422197.

*Point B—C as indicated on the map:* a 590-metre-long footpath commencing at grid reference SE99422197 on the cliff top and proceeding in a north-easterly direction along the cliff top to its junction with the existing public footpath some 125 metres north of the northern end of a large quarry at grid reference SE99762241.

**PART 2**

**Description of site of new path**

*Point A—D as indicated on the map:* a 390-metre-long footpath of a width of 3 metres commencing at grid reference SE99482189 at a point on the existing public footpath and the north-western corner of a small quarry and proceeding in an east-north-easterly direction along a well defined track to a point on the said track being also adjacent to the western boundary of a large quarry at grid reference SE99832205

*Point D—C as indicated on the map:* a 390-metre-long footpath of a width of 3 metres commencing at grid reference SE99832205 being also adjacent to the western boundary of a large quarry and proceeding in a north-north-westerly direction along a well defined track to its junction with the existing public

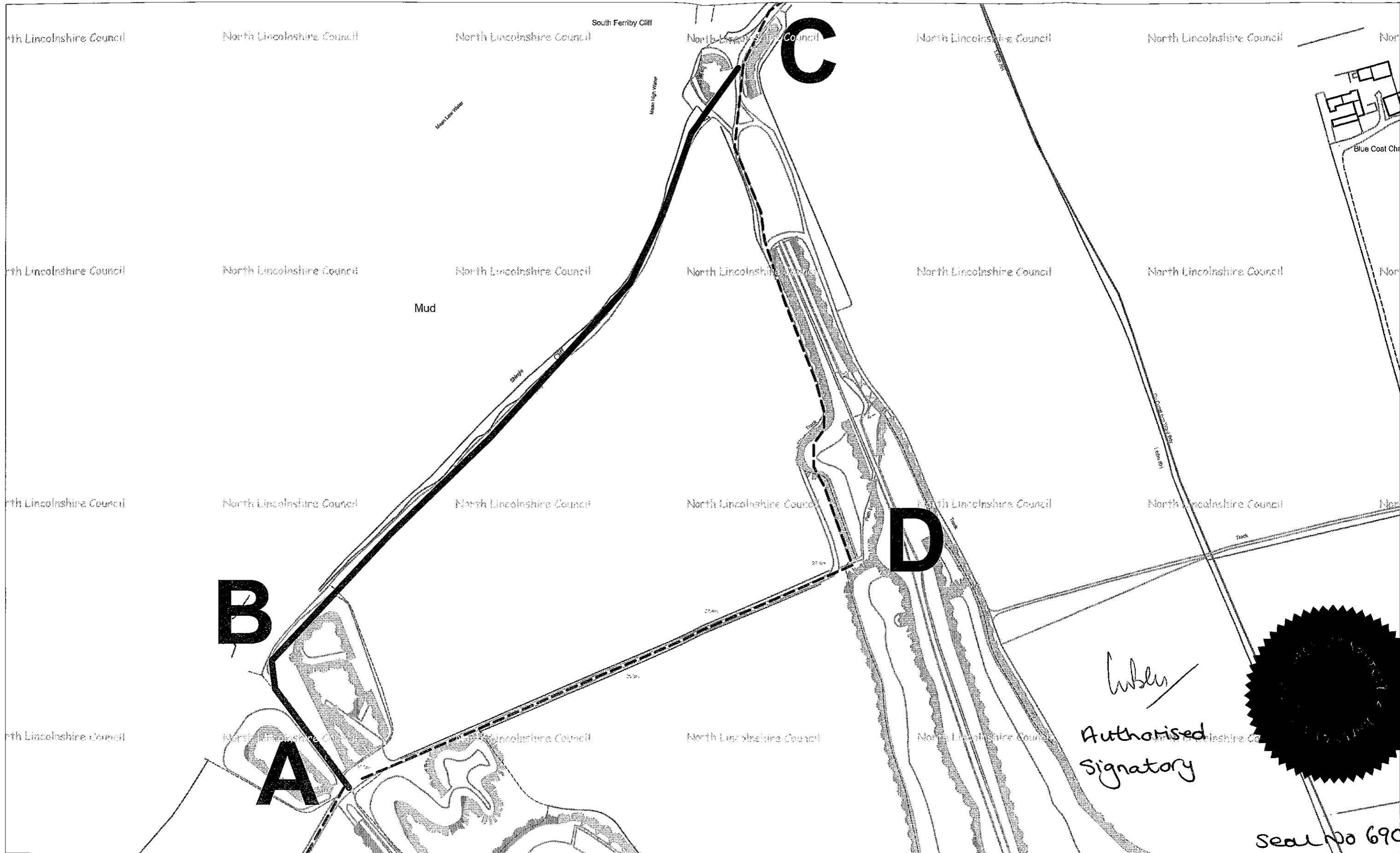
footpath on the cliff top some 125 metres north of the northern end of a large quarry at grid reference SE99762241.

### **PART 3**

#### **Modification of Definitive Statement Variation of particulars of path or way**

A 780-metre-long footpath commencing at a point on the existing public footpath and the north-western corner of a small quarry at grid reference SE99482189, proceeding in an east-north-easterly direction along a well defined track to a point on the said track being also adjacent to the western boundary of a large quarry at grid reference SE99832205, and then proceeding in a north-north-westerly direction along a continuation of the same well defined track to its junction with the existing public footpath on the cliff top some 125 metres north of the northern end of a large quarry at grid reference SE99762241.

The width of the footpath is three metres throughout.
