This Order is made by the North East Lincolnshire Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owners of the land crossed by the public footpath described in paragraph 1 of this order, it is expedient that the line of the path should be diverted.

ConocoPhillips, Brocklesby Estate and Immingham Golf Club has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER

1. The public right of way over the land situated at Immingham and South Killingholme shown by a bold continuous line on the map (Plan 1) contained in this order and described in Part 1 of the Schedule to this order ("the Schedule") shall be stopped up after 28 days from the date of confirmation of this order.
2. There shall at the end of 28 days from the date of confirmation of this order be a public footpath over the land situate at Immingham and South Killingholme described in Part 2 of the Schedule and shown by a bold broken line on the map attached to this order.

SCHEDULE

PART 1

Description of Site of Existing Path or Way (A- B and B - G)

The full width of a section of the Public Footpath within North Lincolnshire commencing at Grid Reference 516421 415573 (Point A on the Plan) where it crosses a ditch and then travels in a south easterly direction to the County Boundary with North East Lincolnshire at Grid Reference 516633 415564 (Point B on the Plan); being a total distance of approximately 212 metres.

The full width of a Public Footpath commencing at the County Boundary with North Lincolnshire at Grid Reference 516633 415564 (Point B on the Plan) to then travel in a south easterly direction for a distance of approximately 261 metres to Grid Reference 516893 415523 (Point C on the Plan), to then continue in a generally south south easterly direction for a distance of approximately 298 metres to Grid Reference 517108 415334 (Point D on the Plan). The Public Footpath then crosses a ditch to then continue in a generally south easterly direction over a golf course for a distance of approximately 334 metres to Grid Reference 517384 415144 (Point E on the Plan), where it turns and continues south for a distance of approximately 68 metres to Grid Reference 517395 415079 (Point F on the Plan), then turns again and continues onward in a easterly direction for a distance of approximately 95 metres to Grid Reference 517489 415093 (Point G on the Plan); being a total distance of approximately 1.056 kilometres.

PART 2

Description of Site of New Path or Way (A - H - J and J - G)

A section of a Public Footpath commencing at Grid Reference 516421 415573 (Point A on the Plan) within North Lincolnshire that initially travels in a southerly direction for a distance of approximately 10 metres to immediately cross a culvert and meet up with the unaffected Public Footpath No 12. within North East Lincolnshire at Grid Reference 516423 415564 (Point H on the Plan). The path then turns east to then follow Public Footpath No 12 for a distance of approximately 10 metres to then cross the County Boundary back into North Lincolnshire via a second culvert and continue in a generally north easterly direction for a distance of approximately 195 metres back to the County Boundary with North East Lincolnshire at Grid Reference 516612 415646 (Point J on the Plan); being a total distance of approximately 215 metres.

A Public Footpath commencing at Grid Reference 516612 415646 (Point J on the Plan), to then travel in a generally easterly direction for a distance of approximately 279 metres to Grid Reference 516872 415621 (Point K on the Plan), where it turns and continues onward in a generally south easterly direction for a distance of approximately 381 metres to Grid Reference 517122 415339 (Point L on the Plan). The path then crosses a ditch via a footbridge where it then turns east and continues onward for a distance of approximately 196 metres to Grid Reference 517316 415371 (Point M on the Plan), the path then turns and continues in a generally southerly direction for a distance of approximately 306 metres to Grid Reference 517450 415117 (Point N on the Plan) to then continue in a generally south easterly direction for a distance of approximately 45 metres to Grid Reference 517489 415093 (Point G on the Plan); being a total distance of approximately 1.207 kilometres.

Width: 2 metres except at 516423 415564 where it is 3.5 metres and 3 metres over the 2 culverts.

Limitations: Bridge at Grid Reference 517122 415339

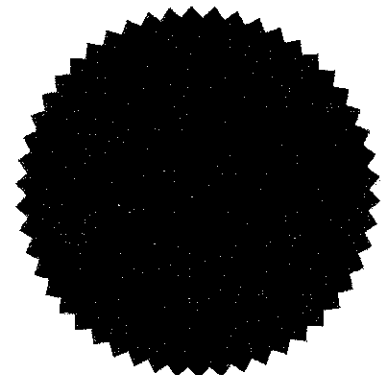

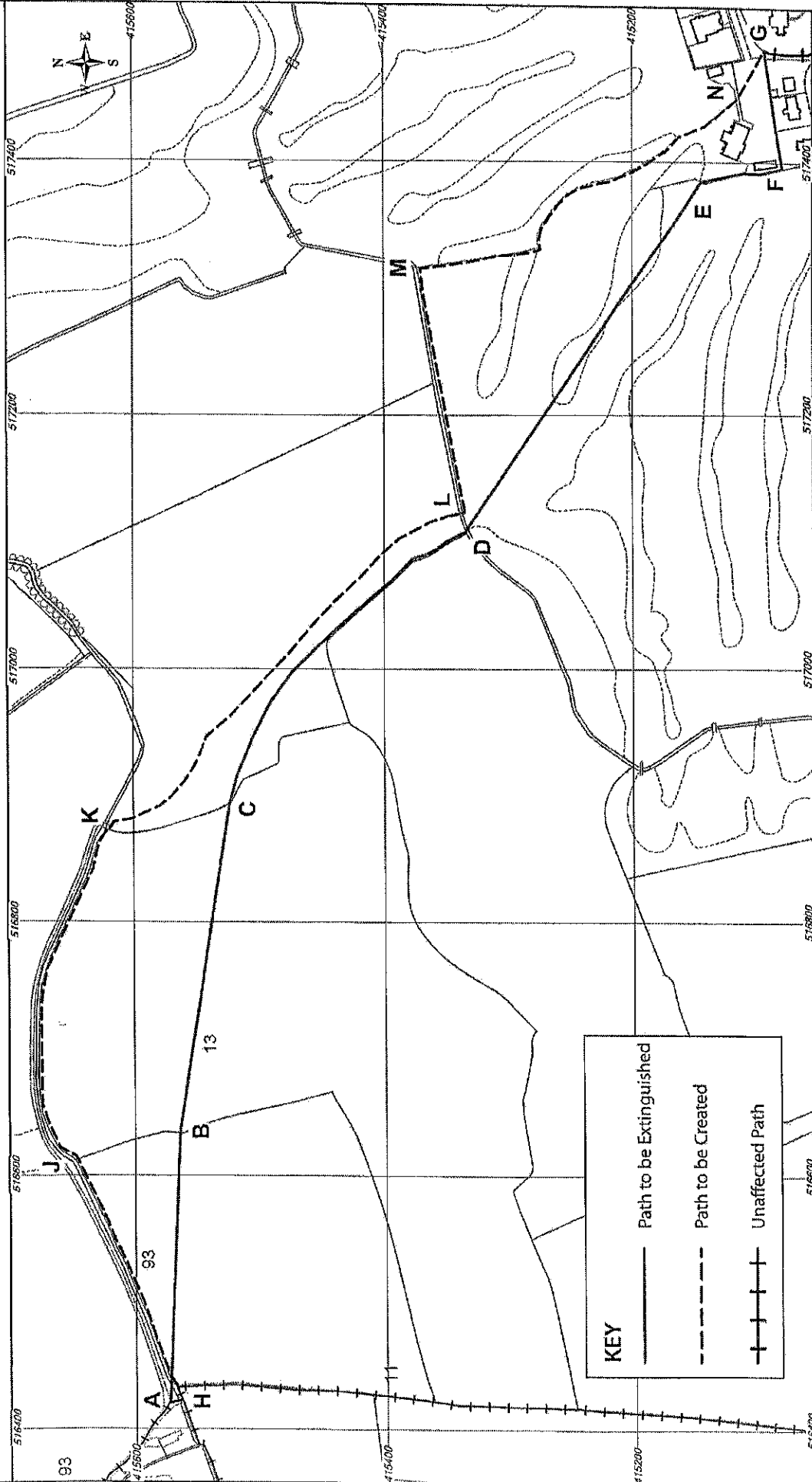
