## Wildlife and Countryside Act 1981

### County of Lincoln - Parts of Lindsey (Isle of Axholme) Definitive Map and Statement

#### Definitive Map Modification (Public Footpath 125 West Butterwick) Order 2005(2)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) - namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended - of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 28th October 2005.
2. The County of Lincoln - Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 125 West Butterwick) Order 2005(2).

### SCHEDULE

#### PART 1

##### Modification of County of Lincoln Parts of Lindsey (Isle of Axholme) Definitive Map

##### Description of path to be deleted

*A – B as indicated on the map:* A 74-metre-long footpath commencing at a point on the existing footpath on the northern boundary of O.S. Field number 1695 at grid reference SE8323105984, proceeding in a south-easterly direction to a point on the existing footpath at grid reference SE8329805954.

Description of path to be added

*A – C as indicated on the map:* A 61-metre-long footpath with a width of 1.2 metres commencing at a point on the existing footpath on the northern boundary of O.S. Field number 1695 at grid reference SE8323105984, proceeding along a tarmacadum path and the northern boundary of O.S. Field number 1695 in a easterly direction to a point 54 metres west of a property known as No.14 The Croft at grid reference SE8328905992.

*C – B as indicated on the map:* A 38-metre-long footpath with a width of 1.2 metres commencing 54 metres west of a property known as No.14 The Croft at grid reference SE8328905992, proceeding along the east side of a high grass bank and the west side of a security fence to a point on the existing footpath at grid reference SE8329805954.

Modification of Parts of Lindsey (Isle of Axholme) Definitive Statement

Variation of particulars of path

A 99-metre-long footpath with a width of 1.2 metres commencing at a point on the existing footpath on the northern boundary of O.S. Field number 1695 at grid reference SE8323105984, proceeding along a tarmacadum path and the northern boundary of O.S. Field number 1695 in a easterly direction to a point 54 metres west of a property known as No.14 The Croft at grid reference SE8328905992, and then along the east side of a high grass bank and the west side of a security fence to a point on the existing footpath at grid reference SE8329805954.

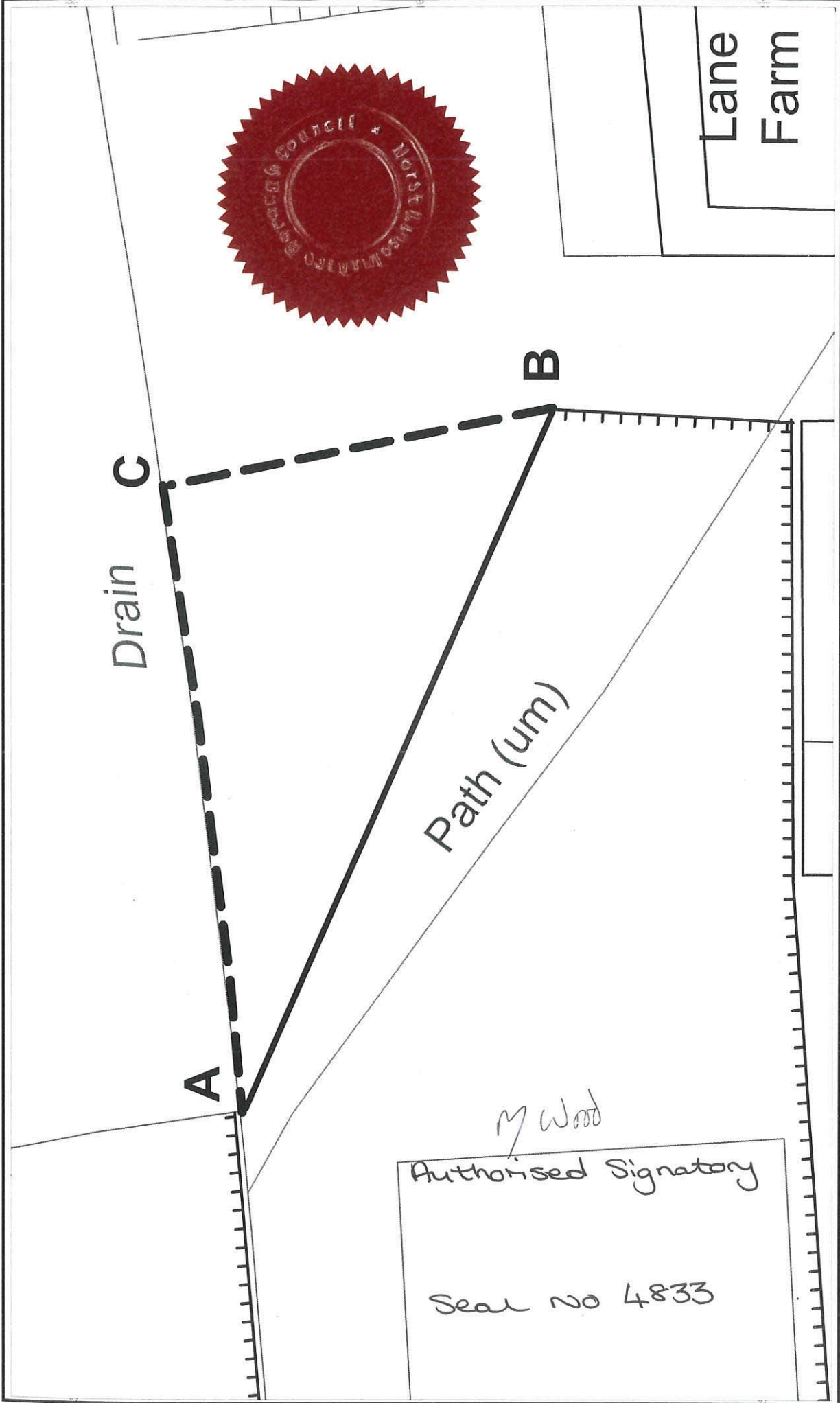

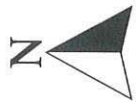
