Definitive Map Modification (Public Footpath 141, Worlaby) Order 2005(2)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 141, Worlaby) Order 2005(2).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 66-metre-long footpath commencing at grid reference TA0129113839 on the existing footpath proceeding in a north-north-westerly direction to the junction with New Road at grid reference TA0125813898.



Description of path to be added

A – C as indicated on the map: A 60-metre-long footpath with a width of 1.8 metres commencing at grid reference TA0129113839 on the existing footpath proceeding in a north-westerly direction to the junction with New Road at a point 28 metres south-west from the original point at grid reference TA0124213877.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 60-metre-long footpath with a width of 1.8 metres commencing on the existing footpath at the northern side of a boundary fence of a property known as No.58 Low Road at grid reference TA0129113839 proceeding along the western side of a boundary fence of a property known as No19 New Road and the eastern side of a boundary fence of a property known as No 21 New Road in a north-westerly direction to the junction with New Road at a point 28 metres south-west from the original point at grid reference TA0124213877.

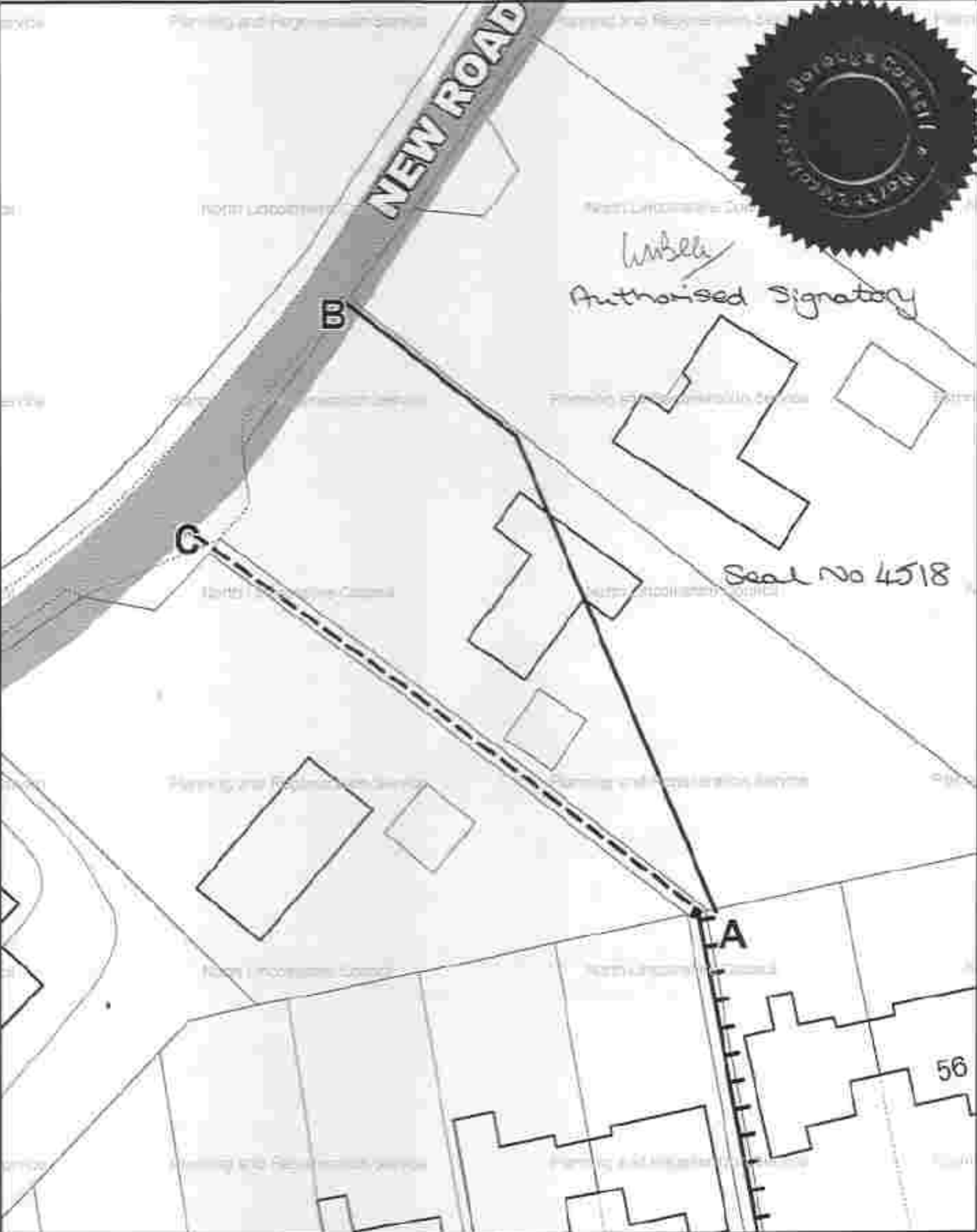
