- 647 **APOLOGIES** – Apologies were received from, Cllr Ogg, Cllr Rowson, David Dransfield, Mark Summers, Ralph Day, Pam Cook, Kian Borg-Jackson, Lorna Fillingham and Peter Mckenzie-Brown.
- 648 **DECLARATIONS OF PERSONAL INTERESTS** – No declarations were received from members.
- 649 **MINUTES - Resolved** - That the minutes of the meeting held on 7 February 2018, having been circulated amongst the members, be taken as read and correctly recorded and be signed by the chairman.
- 650 **MATTERS ARISING** – No matters were raised by members.
- 651 **LOCAL ACCESS FORUM SUB GROUP** –
- I. Discovering Lost Ways – Update from the sub group**  
Dennis Oliver gave an update on the progress made and informed the Forum that he would be looking at lost ways North Lincolnshire wide as some may have been missed.

- II. Iron Stone Walk/Trail – Update from the sub group**  
Members were given an update on the progress made in regards to the opening of the Iron Stone Walk and that Cllr Waltham MBE had agreed to open the walk.

- 652 **DEFINITIVE MAP** – Colin Wilkinson gave an update and advised that he hoped that the Definitive map for Glanford and Brigg would be published in July. An update in regards to the Whitton Footpath was asked for and Colin agreed to chase this up. Colin further updated the Local Access Forum and advised that a notice of a confirmation of a modification order in regards to Middlegate Lane was to be advertised on the 19 April 2018. Hazel Armstrong asked if it was possible to find out how many meters had been added to the Definitive Map since 1996.
- Resolved** – (a) That the update be noted and (b) that Colin Wilkinson to advise at the next meeting how many meters were added to the Definitive Map since 1996.

653 **BRIDLEWAYS UPDATE –**

- **Hirst Priory to Derrythorpe** – Colin Wilkinson informed the Local Access Forum that currently the route was predominantly a public footpath, however once approval had been obtained from Belton Parish Council an order would be placed to upgrade the route to a restricted byway.

654 **ANCHOLME CYCLEWAY UPDATE** – Colin Wilkinson updated members on the progress made on the cycleway and informed members that the route from Brigg to Carr Lane Bonby had been completed and construction had begun on the route from Horkstow Bridge to South Ferriby. Colin further added that talks with land owners were ongoing in relation to joining the route from Horkstow Bridge to Carr Lane Bonby.
