## 1. For Starters

This Statement of Purpose has been written so that you know what support we can give you.

You should have a chance to see this Statement of Purpose. We make sure it is on the Council's webpages [www.northlincs.gov.uk](http://www.northlincs.gov.uk) and we also give it to every young person that we are working with.

Every year we update this so that you can see what we will be doing and what we want to achieve.

We want to give you the best support we can and to do this we will make sure that we listen to your suggestions. We want you to tell us what is working well and if you think there is something we can be doing better. The different ways you can contact us are included in this Statement of Purpose.



## 2. About Special Guardianship

Special Guardians are adults who care for children and young people in their home. A **Special Guardian** is usually someone with a close relationship to you, such as a family member, former foster carer or family friend.

The Special Guardianship Order lasts until you are 18 years of age and so the Special Guardian remains your Guardian until then. Only a Court can make a Special Guardianship Order. The Family Court is where this decision is made.

Special Guardianship is a way of giving you a safe and secure family life while you are growing up. The Order is made when the Court has decided that you cannot live with your birth parents. There are many reasons why the Court may decide you cannot live with your parents.

*\*if you haven't got a copy already, ask for our Young Person's Guide to Special Guardianship as this explains the different reasons why a Court may decide that Special Guardianship is the right plan.*

Unlike adoption, a Special Guardianship Order will not remove parental responsibility from your birth parents. This means that the Special Guardian will have responsibility for the day-to-day decisions as well as all the important decisions about you, but will need to consult your birth parents at times where key decisions are being made such as changing your name, moving overseas or agreeing adoption.



### 3. How we can help

#### We will

- You are all different and have your own opinions so we will listen to you in how best to support you and your family.
- We will ask you what you think about our services. This helps us find out the best way we can help.
- We will ask you for any ideas about things we can do.
- What you say is always important to us.
- We will be respectful.
- We will find out about everyone's needs and make sure all are treated fairly and with respect.
- We will be available to help during any difficult times.
- We will give information about the support and services we provide. We will make sure that we do this by talking and also by writing things down.
- We will try and answer all your questions. Sometimes the answer may be difficult to hear and we will always be around to support you and to help you work it out.
- It's important that you are safe and that you are given every chance to succeed and this means having a goal for your future. We will do whatever we can to help with this.



## Examples of Services we will provide for you;

- We will give you a copy of this Statement of Purpose.
- We can give you a guide to the support we offer.
- We have a Children and Young Person's Guide to Special Guardianship, and you will usually receive this before the Order is made. If you need another copy of this let us know and we will make sure you get a copy.
- We can help with collecting memories and in collecting information for your life story book.
- We can try and help sort out things to do with contact.
- Sometimes you may need to talk to someone else, like a therapist. This can be the case when things feel very complicated and space and time is needed to work some things out. A therapist can sometimes help to do this. Or, it could be that an Adoption Social worker is the best person to help you do this. Either way, we will help you find someone you can talk to on a one to one.
- We will make sure you have the dates for any groups / activities that we run.
- We can arrange different training, for example, we can help schools understand a little more about what it is like to be living with special guardians. Or, you might want to learn about something in particular and if you let us know then we might be able to arrange it.
