**FIXING OF MAXIMUM FARES FOR HACKNEY CARRIAGES**

Notice is hereby given that North Lincolnshire Council intends to vary the rates or fares in accordance with the provisions of section 65 and 66 of the Local Government (Miscellaneous Provisions) Act 1976. The proposals for rates or fares will be as follows: -

**Present Tariff One**

**For journeys commenced after 07:00 hours and before 21:00 hours**

First 175 yards (approx. 160 metres) or part thereof	<b>£2.80</b>
Each subsequent 176 yards (approx. 161 metres) or part thereof	<b>£0.20</b>

**Present Tariff Two**

**For journeys commenced after 21:00 hours and before 07:00 hours and from 07:00 hours to 21:00 hours on Sundays, and all public holidays excluding those covered by tariff three.**

First 117 yards (approx. 107 metres) or part thereof	<b>£3.40</b>
Each subsequent 117 yards (approx. 107 metres) or part thereof	<b>£0.20</b>

**Present Tariff Three**

**For journeys commenced after 18:00 hours on Christmas Eve and New Year's Eve and before 06:00 hours the following morning, and for journeys commenced after 06:00 hours on Christmas Day, Boxing Day and New Year's Day and before 06:00 hours the following morning.**

First 103 yards (approx. 94 metres) or part thereof	<b>£3.80</b>
Each subsequent 103 yards (approx. 94 metres) or part thereof	<b>£0.20</b>

**Additional Charges**

Fares for time	<b>£18.00</b> per hour & pro rata thereof
Waiting time (at any time of day)	<b>£0.60</b> each 2 minutes or part thereof
Additional passengers in excess of four	<b>£1.00</b> for each additional passenger
Journeys crossing the Humber Bridge	<b>Twice the current toll</b>
Soiling charges -Where the taxi is soiled by any passenger or animal which necessitates cleaning before the vehicle can be used again for public hire	<b>up to £75.00</b>
Each animal	<b>£1.50</b> each animal

**Please note – There shall be NO CHARGE for assistance, guide or hearing dogs.**
