NORTH LINCOLNSHIRE BOROUGH COUNCIL
(IDLE BANK)
(TEMPORARY PROHIBITION OF VEHICLES
WEIGHING 7.5 TONNES AND OVER) ORDER 2022

WHEREAS North Lincolnshire Borough Council (hereinafter referred to as “the Council”) are satisfied that vehicles weighing 7.5 tonnes and over should be prohibited from using that length of Idle Bank between Thorne Road and Wroot Road and that length of Idle Bank between Poles Bank and Cove Road.

NOW THEREFORE the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 and of all powers them enabling in that behalf hereby make the following Order.

1. No person shall proceed or cause any vehicle weighing 7.5 tonnes and over to proceed over the afore-mentioned lengths of Idle Bank.
2. Nothing in Article 3 of this Order shall make it unlawful for a heavy commercial vehicle to proceed on any road or length of road to which the prohibition imposed thereby applies, if the vehicle is being used:
 - (a) For or in connection with the conveyance of goods to or from any premises situated on the said lengths of Idle Bank.
 - (b) For the purpose of agriculture on any land situated off the said lengths of Idle Bank or for in connection with the conveyance or haulage of timber felled upon such land;
 - (c) An ambulance, a fire brigade, police or medical practitioner’s vehicle required in an emergency to be on the roads so specified;
 - (d) Vehicle granted special exemption by North Lincolnshire Council;
 - (e) Vehicles being used in the service of North Lincolnshire Council;
 - (f) In connection with the carrying out on premises situated on the said lengths of Idle Bank of any of the following operations – namely building, industrial or demolition operations; and the laying, erection, alteration or repair in or on land adjoining any road of any sewer, main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus;
3. This Order shall come into operation on 7th October 2022 and will continue in force for a period not exceeding 18 months or until the works being undertaken on the said lengths of Idle Bank has been completed whichever is the sooner.
4. This Order may be cited as North Lincolnshire Borough Council (Idle Bank) (Temporary Prohibition of Vehicles Weighing 7.5 Tonnes and Over) Order 2022.
