B.R.303 is subject to the following rights of the British Electricity Authority:-

- i. The Authority's right of access under powers contained in the Gasworks Clauses Act 1847 as incorporated with the Electric Lighting Act 1882 to its cables laid underground along the said bridleway
- ii. The Authority's private vehicular right of way along the bridleway to its electricity substation.

F.P.30 is subject to such rights of access thereover and other rights in connection with the use and development of adjacent lands as have been preserved to the owners of such land by statute or acquired by user.

The public right of way over any public path or other way shown on the map along the bank of a river or drain is subject to any right which a River Board or Drainage Board may have to carry out drainage works in or in connection with such river and drain or to, through, across, or in connection with the bank or banks thereof.

Note

Entries have only been made in this statement in the case of rights of way clearly created or modified by documents. The existence of the right of way or the fact that the County Council alleges that a right of way exists does not depend on an entry in this statement. All rights of way shown on the map are alleged to be public rights of way.

This is the statement approved by the County Council of Lincoln, parts of Lindsey at their meeting on the 15 of December 1968 as a statement accompanying the definitive rights of way map for the Glanford Brigg rural district the urban districts of Barton upon Humber and break and the borough of Scunthorpe except the area excluded from the survey provisions of the act.
